- 9) **Reports of Standing Committees and Connected Groups**
  - a) Airport Operations: Kurt Winker Status is quiet. All lights working as expected. Aviation Grant is in limbo. Manager has filed an additional grant request to work on the taxiway beginning at the south end of the parallel taxiway, go south to create a run-up area, and patch as much as can be accomplished for under \$50,000 (18,000 ft<sup>2</sup> of ramp and taxiway).
  - b) General Operations (Roads): Pat Derieg – Pat met with paving contractor. Crack sealing on Hathaway, down Elaine, and back up Wood. The contractor will also be working on the east end of East-West drive and around Tail Dragger and patch as necessary. Will post email notices when work is scheduled.

  - c) General Operations (Grounds): Dave Hamann very upset about the Tractor and potential repair of same. Resigning from The Grounds Committee as of tonight.
  - d) Architecture Committee: Rick Chavez – not present, Jan Marker to report a modification of the project proposal for Desiati on La Sombra. The project now has one barn up against the

west fence. Recommendation by the committee to approve. Board approves and will sign later.

- e) Planning Committee: Matt Torres wants to thank several people who assisted with the new signage for the Air Park. Craig Oresman, Jerry Donovan, Pat Derieg, Paul Sorensen, Jay Janssen helped install.

Need to start the planning for next fall's Wings & Wheels. A planning group needs a leader and committee to begin the effort.

- f) Bylaws and Covenants: S. Fleming Draft document is still with editor for work to make it reasonably useful for review.
- g) Safety/Security – Jay Janssen – Cameras caught a vehicle and person checking access to vehicles along Luscombe. The system did work as intended. Jay has started a group email address to report incidents or issues for which the cameras might be helpful. It is an email address, to the Safety Committee only.
