

#### Court rules VA must pay for veterans' emergency room care, a decision that may be worth billions

The U.S. Court of Appeals for Veterans Claims said VA has been wrongfully denying reimbursement to veterans who sought emergency medical care at non-VA facilities, and struck down an internal VA regulation that blocked those payments. "All of this is unacceptable," said the ruling, which ordered VA to "re-adjudicate these reimbursement claims." Plaintiffs' lawyers say that based on past estimates by VA, the department is now on the hook for between \$1.8 billion and \$6.5 billion in reimbursements to hundreds of thousands of veterans who have filed or will file claims between 2016 and 2025. VA did not immediately respond to a request for comment.

In 2015, the court struck down a previous version of the internal VA regulation that refused any coverage for an emergency claim when another form of insurance covered even a small part of the bill. The court said the regulation violated a 2010 federal law. This ruling found the department had violated the same federal law with its revision of the reimbursement regulation. The panel said the new rule, issued in January 2018, actually created another obstacle for veterans by forbidding the VA from reimbursing medical expenses for emergency services at non-VA facilities.

An August VAIG report found that in just one recent sixmonth period, VA left roughly 17,400 veterans to pay outof- pocket for \$53 million in emergency medical treatment the government should have covered.

"The Court's decision rights a terrible injustice and its order ensures that veterans who were unjustly denied reimbursement for critical emergency treatment at non-VA facilities will finally be reimbursed," said Bart Stichman, executive director of the National Veterans Legal Services Program, which represented the case that led to this decision. "It is a hard-won victory for hundreds of thousands of veterans." That lawsuit is only the second case the Court of Appeals for Veterans Claims has ever granted class action status. The first was earlier this year.

#### VA.gov—Designed To Be One-Stop For Vets—Missing Critical Links



Three lawmakers, Reps. Gilbert Cisneros, D-CA Max Rose, D-NY, and Chris Pappas, D-NH, on the House Committee on Veterans Affairs penned a letter to VA Secretary Robert Wilkie asking the agency to add Congressionally mandated links to VA.gov and the eBenefits site. The newly revamped website was designed to be a one-stop shop, providing veterans with links to any and all information they would need. However, the site appears to be missing links to some critical resources, some of which are mandated by law.

VA officials, in partnership with the U.S. Digital Service's Veterans Affairs team, relaunched VA.gov last year after initially working on a comprehensive benefits site called Vets.gov. After conversations with more than 5,000 users, the team discovered veterans didn't want a website just for benefits, and the agency opted to move all those services to the VA.gov landing page.

"They don't expect to go to a benefits site for benefits stuff and benefits tools and a health site for health stuff, and have to log in completely differently," Marcy Jacobs, executive director of USDS at VA, told Nextgov during the relaunch of VA.gov. "They want to go to one VA and have a single front door. However, a review by the House Committee staff showed VA.gov was missing links to the agency's Freedom of Information Act page and the federal jobs listing website USAJobs.gov, both required by law to be on the main site. Committee staffers also could not find links to the VA Office of Inspector General on VA's eBenefits website, another Congressional requirement.

"We understand VA's website continues to evolve, including a major redesign last year," the congressmen wrote. "However, we ask that you ensure that the website has all the required information in order to be as useful as possible for our nation's veterans." VA and USDS officials did not respond to requests for comment.

# Two men falsely claimed military service to get their cases moved to a

GREAT FALLS, Mont. — Two Montana men who were sentenced to prison for violating the terms of the probation in separate crimes won't be eligible for parole until they complete a writing assignment given because they falsely claimed to have served in the military to have their cases moved to a veterans court (Veterans Court programs create and supervise treatment plans to address crimes that may be due to servicerelated post-traumatic stress disorder, traumatic brain injury, anger issues or substance abuse.).

Cascade County District Judge Greg Pinski sentenced Ryan Patrick Morris and Troy Allan Nelson. Morris got 10 years in prison for violating the terms of his probation for felony burglary; Nelson got five years on a drug possession conviction. Pinski suspended three years of each defendant's sentence.

Before they can be eligible for parole Pinski ordered both men to hand write the names of all 6,756 Americans killed in Iraq and Afghanistan; write out the obituaries of the 40 Montanans killed in Iraq and Afghanistan and send handwritten letters of apology to several veterans groups identifying themselves as having lied about military service to receive help and possibly a lesser sentence through a veterans court. "I want to make sure that my message is received loud and clear by these two defendants," Pinski said.

Morris claimed in 2016 he did seven combat tours in Iraq and Afghanistan, had PTSD and had his hip replaced after being injured by an IED. He was sentenced to perform 441 hours of community service with a veteran's organization - one for each Montanan killed in combat since the Korean War. Court records said he only completed 10 hours. Nelson managed to get himself enrolled in the Veterans Treatment Court before it was determined he hadn't served in the military.

Once released from prison, they must perform 441 hours of community service. Pinski also ordered that during the suspended portions of the sentences the defendants must stand at the Montana Veterans Memorial in Great Falls for eight hours on each Memorial Day and Veterans Day wearing a placard that says: "I am a liar. I am not a veteran. I stole valor. I have dishonored all veterans."

Attorneys for both men objected to the placard condition. Attorney Mark Frisbie said his client has

not been charged with stolen valor, which is a federal crime, but was being punished for it. Pinski said he was punishing the men for lying to the court. He also cited Montana Supreme Court rulings that give him discretion to take the stolen valor into account and others that upheld the placard requirements

#### **Bankruptcy Protection Law Signed**

Legislation has been signed that prevents debt collectors from seizing veterans' disability compensation if they declare bankruptcy. The Honoring American Veterans in Extreme Need (or HAVEN Act), extends the same protection for veterans disability payments that's afforded Social Security disability payments: By law, debt collectors are now not allowed to count these benefits as disposable income subject to seizure during a bankruptcy. The bipartisan legislation passed by voice vote in both legislative bodies and was widely hailed by veterans groups.

Social Security disability payments have long received protection from bankruptcy creditors. When the HAVEN bill was introduced, Holly Petraeus, former assistant director of the Consumer Financial Protection Bureau, said she was "surprised and dismayed" that disabled veterans' disability income was not shielded in the same manner. "As someone who has spent her life in the military community, I know that many veterans have paid for their dedicated service with lifelong disabilities. It should be a priority for all of us to see that they are treated fairly under the law," she said.

Also signed was an extension of the National Guard and Reservists Debt Relief Act, which offers protection during bankruptcy proceedings to members who serve for at least 90 days on active duty. The legislation ensures that members of the National Guard and Reserves, who may earn higher pay while serving on active duty than they make in their civilian jobs, are not assessed at the higher pay bracket if they file for bankruptcy. The law extends the protections for four years. It was set to expire in December.

# Retirees Could Receive Tricare Refund Check – source Military.com

Military retirees who paid annual Tricare Prime enrollment fees in 2018 or 2019 could soon see a refund check in the mail, thanks to a new change to how the system calculates their annual out-of-pocket maximum payment. The annual maximum out-of-pocket payment, or "catastrophic cap," for any retiree family with a service member who joined the military before Jan. 1, 2018, is set at \$3,000. For those who joined after Jan. 1, 2018, the annual cap is about \$3,600. Those users pay about \$600 per year for plan enrollment, while future retirees will pay close to \$1,000.

After a set of sweeping Tricare reforms went into effect in 2018, the annual fee paid by retirees to use Tricare Prime no longer counted toward the yearly out-of-pocket max. That meant some families were faced with an increase of about \$600 in their yearly Tricare spending. Now, a change, retroactive to 2018, will allow annual enrollment payment to count toward the cap once again, reducing the amount of money retirees might pay out of pocket each year. That means retirees who paid an enrollment fee for Tricare Prime this year or in 2018, and then exceeded their \$3,000 catastrophic cap, could get a refund. "For the 2018 and 2019 enrollment fees credited to the catastrophic cap, the contractor shall notify the beneficiaries by letter of the credit, how the credit was applied, and how a refund can be requested," the Tricare manual update states.

Next year, when retirees who pay their enrollment fees on a monthly basis as a pension allotment hit their out-ofpocket cap, their payments will be automatically halted, the update states. The change will also apply to future retirees who joined active duty after Jan. 1, 2018. By law, they will pay an enrollment fee of almost \$1,000 for Tricare Select. Current retirees do not pay an enrollment fee for that plan.

The change does not impact active-duty users or Tricare for Life users, because they do not pay enrollment fees. It also does not impact monthly premiums paid by users of Tricare Reserve Select, Tricare Retired Reserve Tricare Young Adult.

#### Postal Service selling new Purple Heart stamps

The new Purple Heart Medal Forever stamp is now on sale. The stamp is a redesign that features a purple border matching the purple of the medal and its ribbon. The Purple Heart Medal 2019 stamp is being issued as a Forever stamp in self-adhesive sheets of 20. Customers may purchase stamps and other philatelic products through The Postal Store at usps.com/shop, by calling 800-STAMP24 (800-782-6724), by mail through USA Philatelic or at Post Office locations nationwide.

In addition, the Postal Service has announced it will issue four new stamps to honor those who have received one of the four Service Cross medals. The Distinguished Service Cross, the Navy Cross, the Air Force Cross and the Coast Guard Cross stamps will be dedicated next Memorial Day. The Service Cross medals are the second-highest military decoration for valor in combat, after the Medal of Honor.

More than 20 million Service Cross stamps that will be available at post offices nationwide, online at usps.com or through 800-STAMP-24 (800-782-6724). Being Forever stamps, they will always be good for the current First-Class Mail 1-ounce rate.

# TSA: Man checked missile launcher in luggage at BWI

Federal officials say they've found a missile launcher in a man's luggage at the airport in Baltimore. # Research finds veterans earn more than non-veterans

A new study, "The Veteran wage differential," conducted by the University of Akron looked to see if there was a difference between wages earned by military veterans compared with non-veterans. The study found military veterans earned higher wages, averaging nearly \$26 an hour while non-veterans averaged just \$21 an hour. The study looked at average wages of military veterans and nonveterans across the U.S. between 2005 and 2015. It was conducted by two University of Akron professors, Dr. Francesco Renna and Dr. Amanda Weinstein. "Many people are surprised when I show them that veterans tend to have higher wages than non-veterans," Weinstein said.

They associated the higher wages veterans earn to a number of factors, including the fact that veterans have higher levels of work experience, are often older and more likely to be married and have children. Other factors may be the veterans population tends to choose to enter occupations and industries that require more education and higher skill sets, like engineering, health care and government, according to the study. The third main set of factors the study attributed to the higher wages were skills veterans gain in the military that set them up for success in the civilian world, such as greater cognitive and people skills.

The study looked only at wage and salary income from employment and did not consider the potential benefits veterans can earn, such as disability pay, G.I. Bill stipends, pensions or health care coverage. According to their research, veterans could have increased their wages even more if they would choose to work in more high-paying cities with better business climates. They also found many veterans lose earning potential since the majority don't enter certain high-paying industries such as real estate, finance and insurance.

Being a U.S. Air Force Academy graduate and Air Force veteran herself, Weinstein said she wanted to research this subject since she was in graduate school. "The men and women that I had the opportunity to serve with in the military are highly skilled, dedicated, and hard-working," Weinstein said. "They have a lot to offer the workforce and the data shows that.


