- Approval of the January 2025 meeting minutes (President) Rachel asked the board members present to review the minutes of the October meeting, and for a motion to approve them. - c. 319 NPS ECS Stream Restoration Contract (SB Codorus Creek) Mark made a motion to enter into this contract and Cindy seconded the motion and it was passed unanimously.
- d. 319 NPS Thompson Environmental Stream Restoration Contract (Centerville Creek) Diane made a motion to enter into this contract and Duane seconded the motion and it was passed unanimously.
- e. EXHIP Contract Approvals
 - UNT to Codorus Creek \$71,250 (Lake Lehman Project) Cindy made a motion to enter into this contract and Mark seconded the motion and it was passed unanimously.
 - ii. Beaver Creek \$71,250 Duane made a motion to enter into this contract and Diane seconded the motion and it was passed unanimously.
- f. PAFBC EXHIP Contract Approvals
 - i. UNT to Codorus Creek \$75,000 (Lake Lehman) Mark made a motion to enter into this contract and Cindy seconded the motion and it was passed unanimously.
 - ii. Beaver Creek \$75,000 Cindy made a motion to enter into this contract and Diane seconded the motion and it was passed unanimously
- g. Grant Sponsorship of UNT of East Branch of Codorus Kevin Stough asked us to sponsor a grant through 319 program for design and permitting of a 2,600 linear feet of a headwater stream on his parent's property Cindy made a motion to agree to this grant sponsorship and Diane seconded the motion and it was passed unanimously.

- h. Apply for NFWF Small Watershed grant WILD program for mussel research for 200,000 Mark made a motion to approve with Cindy seconded the motion which was approved unanimously
- i. Watershed Forestry Use 150,000 of YCPC's 2025 DEP grant for riparian buffer creation at 6,000 an acre (25 acres) Diane made a motion to approve and Lettice seconded the motion and the motion was passed unanimously with Rachel abstaining.
- j. Lake Lehman YCPC contract (650,200) Cindy made a motion to enter into this contract and Diane seconded the motion and it was passed unanimously with Rachel abstaining.
- k. K10 Staging District Tree Delivery April 10 at the Pleasant Valley Road office volunteers are needed to help unload trees for WAY and others such as Lancaster Conservancy
