Minutes

Attendance: Diane, Duane, Matt A., Matt H., Ted, Jeff, Jodi, Lettice, Rachel, and Emily Rachel called the meeting to order at 6:04 p.m.

- 7. Approval of the minutes of the April 22nd, 2021, meeting (President). Rachel asked the board members present to review the minutes of the April meeting, and for a motion to approve the minutes. Diane made a motion to approve the minutes. Matt A. seconded her motion. Motion was carried unanimously by all the board members present.
- 8. Treasurer's report & approval of bills (Treasurer).
 - Emily reported on the Talon Settlement Account-SEP cash flow. Total of \$100,252.86. No expenditures to date.
 - Emily reported on WAY's cash flow statement from April 1 through May 25, 2021. Beginning balance of the General Fund (checking) was \$2,392.38. Revenue for the time period totaled \$3,955.54. Total expenses during the same period were \$434.56. The ending balance was \$5,913.36 and net cash flow \$3,520.98. \$4,899.20 is what is left in the WAY funds. **No action was taken on the Treasurer's Report.**
- 9. Secretary's report & communications (Secretary). Emily provided the board with a verbal summary of important correspondence received and correspondence sent. **No action was taken on the Secretary's Report.**
- 10. Committee reports on current and future activities.
 - a. Executive (President) State of the Alliance
 - i. Logo Discussion A discussion occurred on the color sets and logos provided by LUMI. A Zoom poll was launched and completed which showed Logo 1A and Color Set B were the winners!
 - ii. YRK Magazine A discussion occurred on WAY using the YRK Magazine to unveil the new WAY to the public. The consensus was it's a good way to get the word out about the merger and who we are. Plus, it's good promotion for the price. Jodi made a motion to approve spending \$1,100 of General Funds to promote WAY in the fall edition of the YRK Magazine. Diane seconded her motion. Motion was carried unanimously by all the board members present.
 - b. Education and Outreach
 - i. Master Watershed Stewards Program (Jodi, Duane). Jodi gave an update on the MWS program. The MWS are busy doing projects. Hollow Road cleanup went well. Currently planting a rain garden in Fairview Twp. The new class is almost complete, will be getting nine new stewards.

c. Facilitation

- i. York County Countywide Action Plan (YC-CAP) Implementation (Rachel). Rachel provided the following updates:
 - a. CAP Projects: three projects are completed, one underway, and three will begin May/June/fall.
 - b. Year 2 of Implementation, YCPC and YCCD are meeting one-on-one with DEP to help propel action.
 - c. Project Tracker continue to send lead to Rachel.
 - d. The Center for Water Quality Excellence is coming soon. Smart SWM, Century Engineering opportunity moving forward. Fertilizer Bill moved from Senate to House. EPA commented on CWIP.
 - e. Pilot BMP Data Collection Program currently working with York Township. Preparing information to begin outreach to township farmers and landowners.
 - f. Pilot Codorus Water Program concentrated area selected (Barshinger Creek watershed). Job description for part-time position will be posted soon!
 - 1. Education & Outreach Team Letters will be sent to schools for water quality projects. They received 20 responses from a survey the sent to municipalities for newsletter features. Created both a Street2Creek subcommittee and Watershed Week subcommittee for upcoming events.
 - Data Management Team Continuing to work on BMP data collection. Exploring opportunities with ALLARM.

- 3. Project Implementation Partners are continuing to secure funding and are implementing BMPs in the county. Several recent projects were completed, including Terra Farms tree planting and Horn Farm 6-acre Riparian Buffer planting.
- 4. Legislative and Programmatic Changes Draft watershed permit has been submitted to DEP. Restructure discussion is underway on future of committee. Need to build membership.
- 5. Revenue Building Need to build members. Future tasks include outreach on donations, fundraising, partnerships, sponsorships, etc. Should start fundraising for Watershed Week. Ted suggested the committee investigate YCCF private funding; potentially put a piece requesting funding out to all donors within their groups.
- 6. Agricultural Under development. Need to build membership.
