Rachel called the meeting to order at 6:02 p.m.

- 1. Approval of the minutes of the June 24th, 2021, meeting (President) Rachel asked the board members present to review the minutes of the June meeting, and for a motion to approve the minutes. Diane made a motion to approve the minutes. Lettice seconded her motion. Motion was carried unanimously by all the board members present.
- 2. York Countywide Action Plan
 - a. Executive (President)
 - i. LUMI Creative First photoshoot occurred at the beginning of the month, from which we received 55 original images. There will be another photoshoot later this fall featuring different board members. LUMI created a sponsorship deck for Watershed Week. They're also creating a Watershed Week logo. Looking to do a Watershed Week Passport description of events, receive stamp at events, receive prize if completed. Starting video campaigns and continuing social media campaigns.
 - ii. CAP Projects 2020 funds: Penn Township Center Street stream restoration completed. Pine Run completed. Starting Little Creek Golf Course, Dover Twp bioretention, and Springettsbury WWTP. Funding for the buffer planting at Horn Farm is being reallocated to Alliance for the Chesapeake Bay. The rain garden at Fairview Township is planted, but they're still working on soil amendments.
 - iii. DEP 1-1 Meetings and Two-Year Milestones & Progress Update YCPC and YCCD meet monthly with DEP to discuss YCAP implementation. Two-year progress and CAP update conversations continuing. Combining redundant BMPs in the CAP to help streamline reporting. Update CAP/report is due to DEP by Sept. 1st.

b. Committee Reports

- i. Education and Outreach Reaching out to school districts about completing projects. Contacted municipalities regarding newsletter articles.
 - 1. Master Watershed Stewards Program A Riparian Rangers program is starting in York County through the Alliance for the Chesapeake Bay. Street2Creek is underway. Lake Pahagaco moving forward with planting. Northeastern RFB planting should be completed in October.
 - 2. 2021 Watershed Week next Sub-Committee meeting is July 30th. 20 plus events are being planned. This year, we'll have a Clean Water pledge, where participants can get a free tree. Collusion is brewing a Watershed Week beer! Rachel will have a table at the York Fair to start spreading the word about Watershed Week.
 - 3. Street 2 Creek Judging is closed. Next up: notifying winners, press release, getting painting done. During the last week of August at Art Fest, WAY will have a table.
- ii. Project Implementation
 - 1. Watershed Forestry Riparian Rangers next meeting is August 10th at 6:30pm at Northeastern High School. Alyssa Swartz, YCCD, compiling list of buffers within the County and will assign Rangers to help maintain them.
- iii. Legislative and Programmatic Changes Looking for more membership. Reach out to legislatures about bay legislation i.e., fertilizer bill.
- iv. Revenue Building Looking for more membership. Focus on fundraising: Give Local York, Giving Tuesday, sponsorship deck for Watershed Week, etc.
- v. Data Management Didn't have a meeting this month. Next meeting is August 6th at 1pm. Focus on collecting unreported BMPs.
- vi. Agricultural Starting to build capacity within the committee. Anyone with an agricultural background who is interested in joining should contact Rachel.
 - Pilot Codorus Watershed Project YCPC interviewed for Ag Outreach Coordinator position.
 Focusing on Barshinger Creek watershed. Spring 2022 will have a field day centered around this program. Ten \$1,000 vouchers will be handed out to farmers within the watershed for BMP implementation.

2. Pilot Ag BMP Data Collection Program – This initiative is being led by YCCD. They're working to collect Ag E&S/Conservation/etc. plans in four MS4 Townships. All data obtained will be entered into PracticeKeeper. Hoping through this initiative other unreported BMPs will be discovered.

a. Treasurer's report & approval of bills (Treasurer) Emily reported on WAY's cash flow statement from June 24 through July 22, 2021. Beginning balance of the General Fund (checking) was \$5,981.88. Revenue for the month totaled \$0. Total expenses during the same period were \$2,027.28.
