Conowingo Watershed Implementation Plan (WIP)

The Conowingo Dam and reservoir were built in 1928 and are owned and operated by Exelon Corporation. The Conowingo Dam and other dams in the Lower Susquehanna have historically trapped and stored sediment. A 2015 study concluded the Conowingo reservoir has reached approximately 92% capacity, no longer trapping sediment and associated nutrients. The Phase III WIPs did not account for the Conowingo Dam's reduced ability to trap upstream pollution. To address this problem, the Chesapeake Bay Program has been working since December 2017 to develop a WIP specific to the Conowingo Dam.

The Conowingo WIP process is intended to integrate with ongoing efforts to implement best management practices (BMPs), but seeks to go above and beyond what is identified in existing State WIPs. The Conowingo WIP team will bring additional resources to identify, fund, and ultimately implement projects that are identified as part of the Conowingo WIP.

What could this mean for York County? Well, in addition to developing BMPs to satisfy our Countywide Action Plan (CAP) and Chesapeake Bay Pollutant Reduction Plan (CBPRP), we may need to work with the Conowingo WIP Implementation Team to help satisfy the Conowingo WIP. This could entail finding land for BMPs to reduce sediment and nutrient loads that would not count toward meeting our local reduction targets.

The Conowingo WIP is available for review. Your feedback is essential, and will help the Chesapeake Bay Program better evaluate the feasibility, costs, and approach of the Conowingo WIP, while informing the future financing strategy and implementation of the plan.



The **RB Team** had meetings with the PI and DM teams regarding the Funding Map Spreadsheet. Discussion on the evolution of the team is taking place.

YCPC received the NFWF grant to develop a marketing strategy and tools. The **E&O Team** started working with Lumi in November. Stay tuned for exciting improvements! In addition, the team is looking at additional leads for riparian buffer areas, helping DM with FieldDoc BMPs, and participating in many volunteer opportunities. Next meeting is January 13th at 1pm.

The PI Team has identified buffers as the top BMP to focus their efforts. Partners are continuing to secure funding and are implementing BMPs in the County. They started work on a project tracking spreadsheet. The team is holding bi-monthly meetings and the next meeting is January 15th at 10am.

The L&P Changes Team

continues to work on a draft Watershed permitting concept. The Team is seeking a project to go through the DEP pre-app meeting process established between DEP, Lancaster, and York Counties. Next meeting is December 18th at 1pm.

Watershed FriendlyProperty Certification Program

Some property owners have made great strides to lessen stormwater impacts, and some would like to learn how to do more. So, the Penn State Master Watershed Stewards partnered with Nurture Nature Center in the Lehigh Valley to create the Watershed Friendly Property Certification Program. The goal is to unite landowners, both within individual wtaersheds and across PA, to improve and maintain the quality of water resources, while simultaneaously providing habitat for wildlife and pollinators on their property. Property owners must commit to working towards the following

objectives of the Watershed-Friendly Property Program:

Why should you certify your property to be watershed-friendly?

Certifying your property has many benefits, such as:

- Reducing stormwater runoff
- Reducing pollution
- Conserving water
- Supporting wildlife and pollinators



- Protects your local streams and rivers and life that depends on clean water
- Promotes habitat for wildlife, including pollinators
- Recognizes your commitment to protect water resources on your property
- Educates others about healthy watersheds
- Provides you with tools and resources to achieve a watershed-friendly status
- Brings awareness to the Watershed-Friendly Property Program
- Helps support the Master Watershed Steward Program
- Gives you "bragging rights" for your hard work and dedication to protect and improve water quality in your watershed

How do you become certified?

The application is open to anyone who manages properties between 0.1-15 acres, such as homeowners, schools, places of worship, municipal offices, small businesses, and others. To learn more about the program and to become certified, complete the online application found at the following link:

https://nurturenaturecente r.org/programs/community /wfp-cert/.

If you qualify, you will be notified upon submission and will receive a certificate via email from Penn State Extension. Qualifying property owners will also be eligible to order a watershed-Friendly Property sign. Your sign will be shipped to you within two weeks. The first 250 signs will be free! If you do not qualify, you can use provided resources to help make necessary changes to make your property watershed-friendly. Everyone can do their part to improve water quality in their watershed. Healthy waters make healthy communities!



Project Spotlight: Forest Buffers

The Pennsylvania office of the Alliance for the Chesapeake Bay planted 8.72 acres of riparian forest buffer across four sites in the fall of 2020. Three sites were on private property and one was at Little Creek Park in Jackson Township. The Alliance paid for livestock exclusion fencing and stream crossings, trees, shrubs, shelters, stakes, and three years of maintenance. The Alliance's buffer program is built to be easy, quick, and flexible, and to provide sufficient follow-up support to help the tree planting areas truly become forests.

Master Watershed Stewards helped to plant the buffer at Little Creek. They planted 275 native trees and shrubs. Part of that planting includes a "food forest." How exciting! Species such as hickory, maple, paw paw, elderberry, persimmon, and more were planted. Stewards are eager to create educational materials to help park users learn about the vast benefits of riparian buffers, as well as foods produced by native trees and shrubs. The park will also have areas of lawn converted to meadow, another win-win for the environment, including wildlife and pollinators.
