HMSDC's service territory closely aligns with Harris County while emphasizing services within the City of Houston. More than two-thirds of MBE-owned company employees are ethnic minorities, which increases purchasing power in diverse communities of color. To that end, by focusing on the growth of minority-owned businesses, HMSDC impacts directly and indirectly the economic development of minority communities.

HMSDC is the only organization in the greater Houston area which serves all ethnic minority business owners across all industries. Our programs are intentionally designed to close the gaps between minority and non-minority businesses, increasing the "readiness" of participants to compete for private and public sector procurement opportunities. HMSDC's programming is designed in collaboration with the public and private sectors to build capacity and increase the capabilities of minority-owned businesses.
