#### **Event Time Table**

#### **Site Rules**

The show site is indoors on Agility Grass Pro artificial turf. Parking is close by to work from the car. Garage doors may be open on all sides of the arena, including along the ring (4' high x-pens will block the exits). There will be rows of seats provided by the facility, so no outside chairs. All dogs must be on leash at all times, except when in the ring. Exercise and toilet your dog in the fenced yard or surrounding it. Please be courteous to others using the area. No aggressive dogs. Competitors are welcome to set up tents in the grass for outdoor crating space. A warm up jump will be provided for all exhibitors outside.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Smoking is not permitted inside the facility and not encouraged outside near others. If you must smoke, please do it inside your vehicle and ensure that all trash is discarded properly. No alcohol on the premises.

#### **Helpers**

We depend on volunteers to make this a well-run trial. There will be a sign-up board on site. Thank you in advance for all your help.





# **Crating**

No crating inside except for temporary crating if there is a 2-dog conflict.

# **Checking In**

You do not need to check in unless you need to be measured and/or owe entry fees. All entry fees must be paid prior to running your first class. Failure to pay prior to running may jeopardize your results. All competitors in each class must check in at the gate by checking off their name on the call sheet. If you do not check in, the class will not wait for you. Please only check in for the class being walked. Please remember it is your responsibility to be ready at the ring for your run.

## Measuring

Measuring will be done when the judge is available before the class starts. It is the handler's responsibility to know if your dog needs to be measured in accordance with UKI Rules and Regulations. It is also the handler's responsibility to provide the judge/measuring assistant with all information required to have the dog's height properly recorded. This includes Handler Name, UKI Handler Number, Dog Name, UKI Dog Number, Dog's Birthdate and anticipated jump height. Please have this information available prior to having your dog measured.

Please ensure you understand the new criteria regarding dogs being measured. UKI 11th Edition Rule Book.pdf

If a dog is under 3 and newly registered, a temporary measure or proof of the dog's height must be done by the dog's 3rd trial. A permanent measure must be obtained by a UKI official measurer between 12-18 months after the dog's first/temporary measure. Any registered dog that only has a temporary measure, must follow the above rule. If a newly registered dog is over 3, they must obtain a measure by an official UKI measurer by their 3rd trial and this measurement will be permanent. If you ask for a challenge measure when you have a permanent measure, you must state this when you are getting the dog measured so the correct protocol can be followed and you may not continue to challenge a measure when you have challenged it once.

## **Food Services**

Sorry, there will be no food provided on site. Please plan accordingly.

## **Day of Show Entries**

Will be accepted. The Entry fee is \$20/class/dog for regular runs and \$40/dog for Masters Series.

#### **Leash Running**

In UKI you can either leave your leash at the finish or have it leash-run to the finish. You CANNOT put it in your pocket or wrap it around your body in any way.





# **Running Order, Course Maps and Class Results**

A preliminary running order will be posted online by Wednesday night at <u>darkstormservices.com</u>. Please note, this is for information purposes only and may change without notice.

The course maps will be posted online no earlier than 3 hours prior to trial site opening except for Masters Series (posted at time of site opening).
