Site Rules

The show site is indoors on turf. Please bring your own crate, clean up supplies, & water for your dog. Waterproof mats under crates are required.

All dogs must be on leash at all times, except when in the ring or practice jump. Exercise and toilet your dog in designated areas. Please scoop poop and use garbage containers on the site. Do not walk dogs on the nearby businesses' properties or grounds. Any accident on the turf will cost \$10.

A warm up jump will be provided for all exhibitors. There is NO SMOKING inside of the building or near the doors.





Helpers

We depend on volunteers to make this a well-run trial. There will be a sign-up board on site. Thank you in advance for all your help.

Checking In

You do not need to check in unless you need to be measured and/or owe entry fees. All entry fees must be paid prior to running your first class. Failure to pay prior to running may jeopardize your results. **All competitors in each class must check in at the gate** by checking off their name on the call sheet. If you do not check in, the class will not wait for you. Please only check in for the class being walked. Please remember it is your responsibility to be ready at the ring for your run.

Measuring

Measuring will be done when the judge is available before the class starts. It is the handler's responsibility to know if your dog needs to be measured in accordance with UKI Rules and Regulations. It is also the handler's responsibility to provide the judge/measuring assistant with all information required to have the dog's height properly recorded. This includes Handler Name, UKI Handler Number, Dog Name, UKI Dog Number, Dog's Birthdate and anticipated jump height. Please have this information available prior to having your dog measured.

There is a new rule about measuring:

If a dog is under 3 and newly registered, a temporary measure or proof of the dog's height must be done by the dog's 3rd trial. A permanent measure must be obtained by a UKI official measurer between 12-18 months after the dog's first/ temporary measure. Any registered dog that only has a temporary measure must follow the above rule. If a newly registered dog is over 3, they must obtain a measure by an official UKI measurer by their 3rd trial and this measurement will be permanent.

Food Services

Sorry, there will be no food provided on site. Please plan accordingly.

Day of Show Entries

Will be accepted. The Entry fee is \$20/class/dog for regular runs and \$40/dog for Masters Series.

Leash Running

In UKI you can either leave your leash at the finish or have it leash-run to the finish. You CANNOT put it in your pocket or wrap it around your body in any way.





Running Order, Course Maps and Class Results

A preliminary running order will be posted online by Wednesday night at darkstormservices.com. Please note, this is for information purposes only and may change without notice.

The course maps will be posted online no earlier than 3 hours prior to trial site opening except for Masters Series (posted at time of site opening). The website is darkstormservices.com (follow the link for the appropriate trial). We will not be printing results; we will be utilizing “real time results” for this trial. You will be able to access the results on darkstormservices.com.

Online Results

All clear round/qualifying results will be available to view within 2 weeks of the trial. You will be able to log onto your account and see results that were clear rounds, gaining level points.
