#### **Event Time Table**

## **Site Rules**

PARKING: Please Park where Premier staff has indicated. Absolutely no double parking is allowed in the front lot. All must park between the lines. The Main Entrances to the Arena are doors on either side of the front of the building.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Smoking is not permitted inside the facility and not encouraged outside near others. If you must smoke, please do it inside your vehicle and ensure that all trash is discarded properly. No alcohol on the premises

Overnight Parking: Camping/Overnight Parking must be prearranged. Email Requests must be sent to Susan Bintlif—sabledogs@icloud.com Vehicles not in compliance with parking rules will be towed at the owner's expense.

Dog Exercise Areas: Premier Sports Center has four acres of grass for you and your dogs to enjoy. All dogs need to be on leash while on Premier Sports Center property. The only exceptions for off leash are when at the practice jump or in the ring. Poop bags are to be discarded in outside trash receptacles only. Do not walk your dog on our business neighbor's properties. Pay attention to your dog and pick up after your dog. Anyone seen in person or on video not picking up after their dog or walking on the neighbor's property will be subject to a bench hearing and immediate excusal from the Center for the remaining day(s) of the trial. Do not let your male dog lift its leg on the building, front landscaping, or on any item a human needs to handle. Please be considerate of the public restrooms. Trash cans will be placed in the bathrooms for proper disposal of paper products other than toilet paper. No dogs allowed in public restrooms.Personal





chairs/handicap chairs will not be allowed on the turf field. We will provide bench seating in the front of the rings for all to use. Please remove your personal belongings when your class has ended.

Sports Center Hours: The Center will close, and doors will be locked approximately one hour after the last run has completed for the day. Be prepared.

## **Helpers**

We depend on volunteers to make this a well-run trial. There will be a sign-up board on site. Thank you in advance for all your help.

## **Crating**

Climate controlled Indoor Crating is allowed in designated areas. You must bring a tarp to put under your crate.

## **Checking In**

You do not need to check in unless you need to be measured and/or owe entry fees. All entry fees must be paid prior to running your first class. Failure to pay prior to running may jeopardize your results. All competitors in each class must check in at the gate by checking off their name on the call sheet. If you do not check in, the class will not wait for you. Please only check in for the class being walked. Please remember it is your responsibility to be ready at the ring for your run.

## Measuring

Measuring will be done when the judge is available before the class starts. It is the handler's responsibility to know if your dog needs to be measured in accordance with UKI Rules and Regulations. It is also the handler's responsibility to provide the judge/measuring assistant with all information required to have the dog's height properly recorded. This includes Handler Name, UKI Handler Number, Dog Name, UKI Dog Number, Dog's Birthdate and anticipated jump height. Please have this information available prior to having your dog measured.

#### There is a new rule about measuring:

If a dog is under 3 and newly registered, a temporary measure or proof of the dog's height must be done by the dog's 3rd trial. A permanent measure must be obtained by a UKI official measurer between 12-18 months after the dog's first/temporary measure. Any registered dog that only has a temporary measure must follow the above rule. If a newly registered dog is over 3, they must obtain a measure by an official UKI measurer by their 3rd trial and this measurement will be permanent.

#### **Food Services**

Sorry, there will be no food provided on site. Please plan accordingly.

#### **Day of Show Entries**

Will be accepted. The Entry fee is \$20/class/dog for regular runs and \$40/dog for Masters Series.





## **Leash Running**

In UKI you can either leave your leash at the finish or have it leash-run to the finish. You CANNOT put it in your pocket or wrap it around your body in any way.

## **Running Order, Course Maps and Class Results**

A preliminary running order will be posted online by Wednesday night at <u>darkstormservices.com</u>. Please note, this is for information purposes only and may change without notice.

The course maps will be posted online no earlier than 3 hours prior to trial site opening except for Masters Series (posted at time of site opening). The website is <u>darkstormservices.com</u> (follow the link for the appropriate trial). We will not be printing results; we will be utilizing "real time results" for this trial. You will be able to access the results on <u>darkstormservices.com</u>.

#### **Online Results**

All clear round/qualifying results will be available to view within 2 weeks of the trial. You will be able to log onto your account and see results that were clear rounds, gaining level points.
