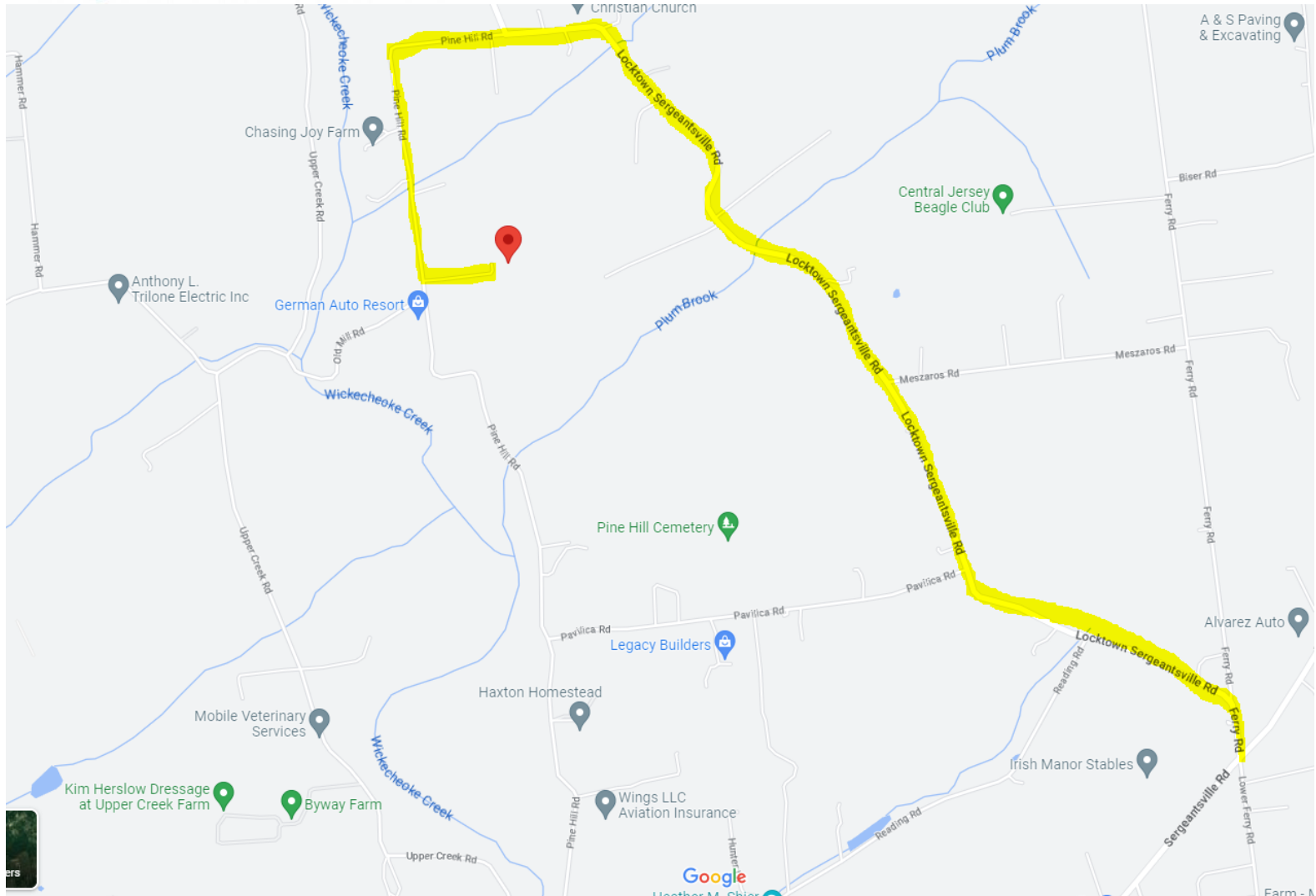
Briefing at 5:45 pm

**Location**

The site has a red brick driveway. The driveway is just north of where Old Mill Rd meets Pine Hill Rd. If coming from the South and East, we recommend taking Locktown-Sergeantsville Rd to Pine Hill Rd to avoid a gravel road. That is to say “do not take Pavilica Road” from Locktown-Sergeantsville Rd. Also, do not get on Pine Hill Road from Rosemont-Ringoes Rd. It takes you on a barely paved, narrow, windy path through the woods. Instead, continue up Locktown-Sergeantsville Rd to where it turns 90 degrees left near Cornerstone Christian Church and meets/changes name to Pine Hill Road, then take Pine Hill to the west and it bends South to the driveway.





## Site Rules

This is an active horse farm. Dogs must be on leash at all times when not running in the ring or using the practice jump. Please do not enter any of the smaller barns or horse pastures for any reason. If your dog is obsessively barking at the horses, you will be asked to move your car. Please do not allow dogs to lunge, stalk or otherwise go up to horses. There is no smoking anywhere on the property.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement.

Note: one port-a-potty, near side entrance.



### Crating

Plan to work out of your car. Every parking spot is within view of the barn.

### Helpers

We depend on volunteers to make this a well-run trial. There will be a sign-up board on site. Thank you in advance for all your help.

### Checking In

You do not need to check in unless you need to be measured and/or owe entry fees. All entry fees must be paid prior to running your first class. Failure to pay prior to running may jeopardize your results. **All competitors in each class must check in at the gate** by checking off their name on the call sheet. If you do not check in, the class will not wait for you. Please only check in for the class being walked. Please remember it is your responsibility to be ready at the ring for your run.

### Measuring

Measuring will be done when the judge is available between 5p and 5:45p. It is the handler's responsibility to know if your dog needs to be measured in accordance with UKI Rules and Regulations. It is also the handler's responsibility to provide the judge/measuring assistant with all information required to have the dog's height properly recorded. This includes Handler Name, UKI Handler Number, Dog Name, UKI Dog Number and anticipated jump height. Please have this information available prior to having your dog measured. A dog needs one measurement before age 2 and one measurement after age 2.

### Food Services

Sorry, there will be no food provided on site. Please plan accordingly.

### Day of Show Entries

Will be accepted. The Entry fee is \$20/class/dog for regular runs and \$40/dog for Master Series.

### Leash Running

In UKI you can either leave your leash at the finish or have it leash-run to the finish. You CANNOT put it in your pocket or wrap it around your body in any way.

### Running Order, Course Maps and Class Results
