Mayor Tom LaMont said a prayer for guidance.

Speakers: Gregory Scheer candidate for District Magistrate introduced himself and thanked Council for their time and consideration.

Street Department: President Kelly inquired if anyone had any questions on the Street Department Report. Councilman Granahan stated he scheduled a meeting with the Street Department regarding tree removal and replanting on Public Avenue. No other questions or comments.

Zoning Report: President Kelly inquired if anyone had any questions on the Zoning Report. No questions or comments.

Code Enforcement Report: President Kelly inquired if anyone had any questions or comments on the submitted Code Enforcement Report. Code Enforcement Officer Dave Darrow stated he took care of all complaints turned in to him. Officer Darrow stated he would talk to Patty Aiken again regarding the trash at the top of Public Avenue. Mayor's Report: Mayor Tom LaMont stated he has a meeting on Friday at 5PM with Police Department. Mayor LaMont stated if anyone has any Girl Scout Silver Award ideas to let him know. Mayor LaMont then let Linda LaBarbera candidate for District Magistrate have the floor. LaBarbera introduced herself and thanked Council for their consideration.

Action Items:

- **1. Approve Memorial Day Parade:** Councilman Reimel made motion to approve Memorial Day Parade on May 29, 2023. Councilman Herd 2nd the motion. All in favor, motion carried.
- **2. Motion to Move \$100,000 From General Account To Capital Reserve :** Councilman Reimel made the motion to move one hundred thousand dollars and no cents from General Account to Capitol Reserve Account. Councilman Chamberlain 2nd the motion. All in favor, motion carried.
 - **3. Motion to Accept 2023 Paving Bids:** Secretary Alyssa Brace opened both sealed bids. First bid opened was Wayco at a bid of one hundred seventy-nine thousand, ninety -nine dollars and eighteen cents. Second bid open was Suit-Kote at a bid of one hundred forty- five thousand, nine hundred sixty-nine dollars and eighty cents. Councilman Reimel made the motion to accept Suit Kote paving bid at one hundred forty five thousand nine hundred sixty nine dollars and eighty cents. Councilman Herd 2nd the motion. All in favor, motion carried.
 - 4. Approval to Advertise Engineered Building Electrical, HVAS, Plumbing, and Heated Concrete Floor Bids: Councilman Reimel made the motion to approve advertising of bids. Councilman Schuster 2nd the motion. All in favor, motion carried.
 - **5.** Approval for Street Department to Purchase Cinders:

Councilman Schuster made the motion to allow Street Department to purchase cinders needed. Councilman Reimel 2nd the motion. All in favor, motion carried.

Discussion Items:

- 1. Food Truck Permitting for Special Events: Councilman Reimel stated he no longer needed to discuss this. There was confusion and it stands corrected. No others discussion needed.
- 2. Curbing at Post Office: Councilman Chamberlain stated he and his Secretary have noticed a lot of falls at the Montrose Post Office, along the roadway stepping up onto their sidewalk. He stated they need to look into installing a ramp so the tripping hazard will be corrected. President Kelly stated that Council could send to Postmaster a courtesy letter. No other discussion needed.
