#### **PUBLIC HEARING**

- **9. Adopt Resolution UFC 2022-06:** Councilman Schuster made motion to adopt Resolution UFC 2022-06; Councilman Granahan 2<sup>nd</sup> the motion. All in favor, motion carried.
- **10. Contact PA DEP about Gas Drilling:** Councilman Granahan stated the noise is constant and residents in the surrounding area are having

an issue and this has been going on for months. Councilman Reimel stated the noise should have stopped. Fracking is finished. Councilman Granahan stated no phone call or contact needed to be made if the noise was indeed over.

#### 11. Possible Letter to PA American Water Regarding Lake Ave:

Councilman Granahan inquired on the Lake Ave project. Wanted to know when repairs to the top of the avenue by the courthouse would be made. Granahan stated the Secretary should send a letter or contact Penn Dot on this matter. Councilman Reimel stated it was temporary fill, due to the construction company needing to reopen the roadway. Reimel stated the deal was when they were done with the project they would grind up the driving surface and lay down new layer. Councilman Schuster questioned, "when next year, they are done for this year". Councilman Reimel stated they were not done for the year. President Judy Kelly stated you could go to the gentlemen in the white helmet to ask questions. Lillian Senko offered to get in contact with Brian Small at Penn Dot regarding Councils concerns. President Kelly stated that we should ask Mr. Small to attend a Borough Council meeting so the public can understand this is a Penn Dot issue and not a Borough issue. All were in agreement this was in the Councils best interest.

### 12. Permission to set up Free Library at Memorial Park:

Councilman Reimel stated "No, unfortunately books would be left all over just like the balls that he picks up all the time". Suggestions we discussed as to where another location would work. President Kelly stated maybe the resident could attend a Council meeting with a proposal site for Council to review.

- **13. Approve final UFC Expenditure \$2,143.00:** A motion was made by Councilman Granahan to purchase the United Fire Company Plaque for the electronic sign at cost of two thousand one hundred forty-three dollars and zero cents. Councilman Reimel 2<sup>nd</sup> the motion. All in favor, motion carried.
- **14. Boring on Vacant Lot:** Councilman Reimel made a motion to accept the boring bid from ARM Group of Jessup at the cost of nine

thousand six hundred sixty-five dollars and zero cents. Councilman Granahan 2<sup>nd</sup> the motion. All in favor, motion carried.

**15. Replacement of Dead Trees on South Main Street:** Councilman Granahan stated he would like set funds aside to replace dead trees on South Main Street. Councilman Reimel stated that we have a tree fund with six thousand dollars and zero cents. Will wait until spring to plant trees.
