**Police Department:** Vice President Herd asked if there were any questions or comments on the Police Report.

Chief Dale Smith updated Council on the recent bank robbery at First National Bank. The tellers do not have panic alarms and by the time the thief left and they called 911 it was too late for Montrose to get involved. Chief

Smith said the getaway car was in HoMart parking lot and the FBI is handling everything since it's the same crew that hit banks at Athens, Plains and other locations.

**Municipal Authority:** Vice President Herd asked if there were any questions or comments on the Municipal Authority Report. No questions or comments.

**Mayor's Report:** Mayor Tom LaMont informed Council he had a meeting with the Officers on the 16<sup>th</sup> of September going over policy, procedures, covid protocol and radar. Officers need to get out a little more and have more visibility.

Its tough being the County Seat and losing tax rolls to another government entity especially one who requests the same or more coverage.

A new state bill out for review discusses doing away with Civil Services for departments of ten or less. It'll be interesting to watch.

  Councilman Reimel motioned to approve transferring the Fire Relief
  Payment of seven thousand five hundred thirty-one dollars and ninetyfour cents (\$7,531.94) to United Fire Company; Councilman
  Chamberlain 2<sup>nd</sup> the motion. All in favor, motion carried.

- **4. Approve Halloween Ad:** Councilman Reimel motioned to approve the Halloween ad to be placed in the local paper; Councilman Chamberlain 2<sup>nd</sup> the motion. All in favor, motion carried.
- **5. Hire Parking Enforcement Officer:** Councilman Schuster motioned to hire Daryan VanNostrand at fifteen dollars (\$15.00) per hour; Councilman Chamberlain 2<sup>nd</sup> the motion. All in favor, motion carried.
- **6. Approve \$6,241.00 Spend for 100 Ton Salt Order:** Councilman Schuster motioned to approve spend of six thousand two hundred forty-one dollars (\$6,241.00) for a salt order of one hundred (100) ton; Councilman Chamberlain 2<sup>nd</sup> the motion. All in favor, motion carried.
- 7. Approve Donation of \$1,000.00 for Christmas in Montrose: Councilman Schuster motioned to donate one thousand dollars (\$1,000.00) to the Christmas in Montrose committee; Councilman Reimel 2<sup>nd</sup> the motion. All in favor, motion carried.
- **8. Approve Ad for "Fill the Cruiser" Veterans:** Councilman Reimel motioned to approve an ad for Fill the Cruiser to collect food for Veterans for the upcoming holidays; Councilman Follert 2<sup>nd</sup> the motion. All in favor, motion carried.

- 2. **Update: Mobile Food Vending Ordinance:** Council spoke about the procedures for the Mobile Food Vending applications and collection of fees.

turns bad they could always stay at the station. Council thought it was a good idea.
