1. Introduction

1.2 Service Overview

CORE Tutors Ltd provides educational services, specializing in GCSE and A-level tuition.

1.3 Agreement to Terms

Enrollment in our services signifies acceptance of these Terms and Conditions.

2. Enrollment and Registration

2.1 Enrollment Process

To enroll, complete all sections of the registration form and sign and date the Terms and Conditions.

2.2 Eligibility Criteria

Students must be studying for GCSE or A-level examinations.

2.3 Registration Fees

A non-refundable registration fee of £10 is required.

3. Fees and Payment Terms

3.1 Service Costs

- £12.5 per hour for Year 10/Year 11
- £15 per hour for Year 12/Year 13

3.2 Payment Deadlines

Payments are due monthly on the last Saturday of the previous month.

E.g. If the first Saturday of April is the 5th, payment will be due on Saturday 29th of March.

3.3 Accepted Payment Methods

Payments are to be made in cash. A receipt will be issued upon payment.

If you have any concerns regarding cash payments, please contact management to discuss alternative arrangements.



3.4 Consequences of Late Payment

Admin fees for late payments are applicable in order to cover any costs incurred as a result of lateness. The cost is at the discretion of CORE Tutors.

3.5 Refund Conditions

Refunds are provided only in exceptional circumstances and at the discretion of CORE Tutors.

4. Class Schedule and Attendance

Absences must be communicated **at least 72 hours** in advance via text message or phone call. Unnotified absences will not be refunded. For example, if your child's lesson is on Saturday at 9am, you will need to notify CORE Tutors before Wednesday 9am to be eligible for a possible refund.

4.4 Lateness

A grace period of [10] minutes is allowed for late arrivals.

4.5 Holiday Schedule

The centre observes national holidays and scheduled breaks. These will be communicated in advance and will not count as absences.

4.6 Parental Responsibility

Parents/guardians are responsible for ensuring their child's regular attendance and punctuality.

4.7 Centre Closures

In the event of unforeseen closures (e.g., inclement weather), affected classes will be rescheduled or reimbursed.
