- Phyllis to investigate alternate tax payors to complete filing taxes. Taxes were never previously filed. Freedom Tax is working to complete all the necessary years.
- Continue the work to complete changes needed to bylaws Comparison to be done with examples prior to committing to Lawyer fees.
- Mr. Zack Pannell presentation- HOA agrees that we will not purchase a laptop for HOA business. All HOA documents and correspondence to be backed up on a secured cloudbased system.
- Hector to investigate how access to Phase II and Phase III will be for new construction.

# 5. NEW BUSINESS

- Based on recommendations of city officials, although not required, board meeting minutes will now be filed with the county.
- On 2 April 2022, a complaint, regarding a potential violation, was received from Mrs.
  Rosemarie Hill. Heather, Charlene, and Gene surveyed the neighborhood to verify
  potential violations. Four homes were sent notices that their structures were
  grandfathered in per the ballots published 30 August 2021. There were 6 violations in
  total and notices were sent to homeowners with instruction on how to correct the
  potential violations. Two homeowners have sent email responses and the HOA will
  address.
