



### **INCIDENTS HISTORICAL**




# **INCIDENTS BY MUNICIPALITY 2024**




### **INCIDENTS BY DISPATCH TYPE/ NATURE-2024**




#### **INCIDENT OUTCOME-2024**

Average Mobilization Time (Time call is received until responding): **1.5 minutes**Average Response Time: (Time from responding to arrival on scene): **9.1 minutes** 


Engagement Time: (responding until patient contact) 12.2 minutes

#### **CORPORATE NEWS**

- > The **SCCEMS Board of Directors** met on April 18<sup>th</sup> at Jenner's Pond
- ChristianaCare West Grove Campus- We continue to our communication with ChristianaCare. CEO Bob Hotchkiss met with ChristianaCare SVP Doug Azar and Regional Executive Director, Southeast Pennsylvania Pauline Corso in April.
  - Opening of new ER still scheduled for early 2025
  - The east wing will become the new ER and support areas
  - o 10 ER beds and 10 hold beds
  - The new facility will be managed and operated by Emarus, a for-profit medical management company
  - o The reminder of the hospital will be demolished to make way for a new healthplex
  - MEDIC 94 and ChristianaCare will be partnering for the pre-hospital blood program
- New Facility- Construction of the new MEDIC 94 station is progressing with trusses going up today. We continue to be on schedule for a September opening. We continue to seek funding for the closeout costs of the new building. MEDIC 94 will be responsible for approximately \$25,000 of fit-out costs (paint/flooring) as well as furniture and appliances for the new building which were not included in the bid. We have obtained approximately \$25,000 in grants and donations so far to cover the furniture and appliances. We are pursuing donations from local philanthropic and community foundations to offset these costs.

#### CARDIAC ARREST DATA

Each year, approximately 350,000 persons in the United States experience an out-of-hospital cardiac arrest (OHCA) or sudden death; approximately 90% of persons who experience an OHCA die. Despite decades of research, median reported rates of survival to hospital discharge are poor (10.4%) and have remained virtually unchanged for the past 30 years. Without a uniform and reliable method of data collection, communities cannot measure the effectiveness of their response systems, nor can they assess the impact of interventions designed to improve OHCA survival. Participation in an OHCA registry enables communities to compare patient populations, interventions, and outcomes with the goal of identifying opportunities to improve quality of care and ascertain whether resuscitation is provided according to evidence based guidelines. CARES was developed to help communities determine standard outcome measures for out-of-hospital cardiac arrest (OHCA) locally allowing for quality improvement efforts and benchmarking capability to improve care and increase survival. Overall, the CARES program seeks to:

- Save more lives from OHCA
- Strengthen collaboration between 911 centers, first responders, emergency medical services (EMS) agencies and hospitals.
- Provide a simple, confidential process for assessing patient outcomes in compliance with HIPAA.
- Offer technical assistance (TA) to help community leaders identify and prioritize opportunities to improve EMS performance.
- Generate annual national and statewide reports for benchmarking capability.

MEDIC 94 has participated in the CARES program for over a decade. This allows us to evaluate performance to de-identified aggregate statistics at the local, state, or national level and discover promising practices that could improve emergency cardiac care.
