Southern Chester County EMS-MEDIC is excited to learn of ChristianaCare purchase of the now closed Jennersville Hospital and its re-opening later this year. MEDIC 94 has a longstanding clinical partnership with ChristianaCare where our paramedics transport a majority of our high-acuity patients. As the closest trauma, stroke and cardiac center to our district, we have come to trust their clinical excellence for our patients. We look forward to the expansion of their expert, caring partnership of healthcare into the southern Chester County community.

MEDIC 94 will continue to maintain its additional paramedic staffing instituted after the closing of the hospital to assure the community receives the level of advanced life support services that it has come to expect. As the hospital opens and capabilities are added, we will adjust our staffing models to the needs of the community. We also call the hospital home to our headquarters and MEDIC 941 station. We look forward to partnering with ChristianaCare to maintain our presence on the hospital campus.

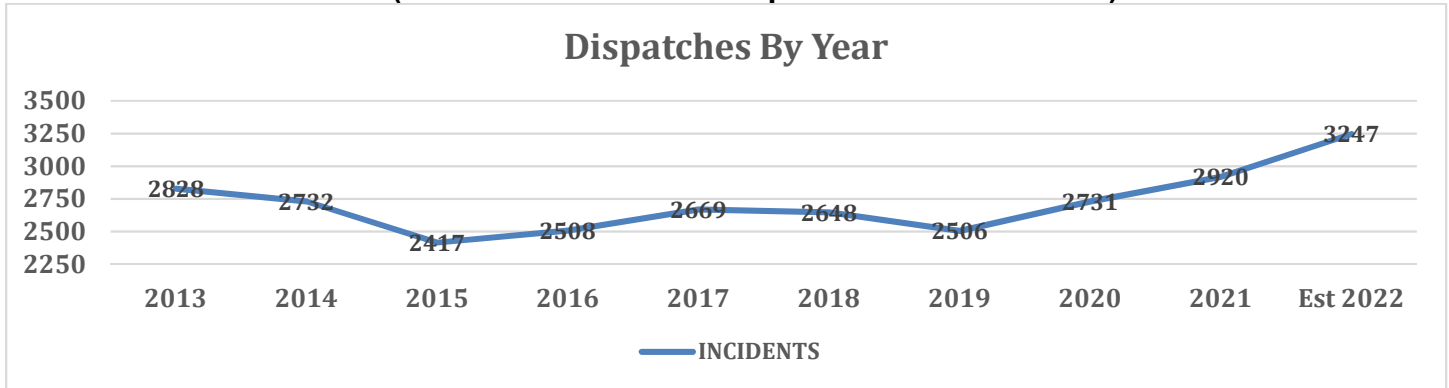

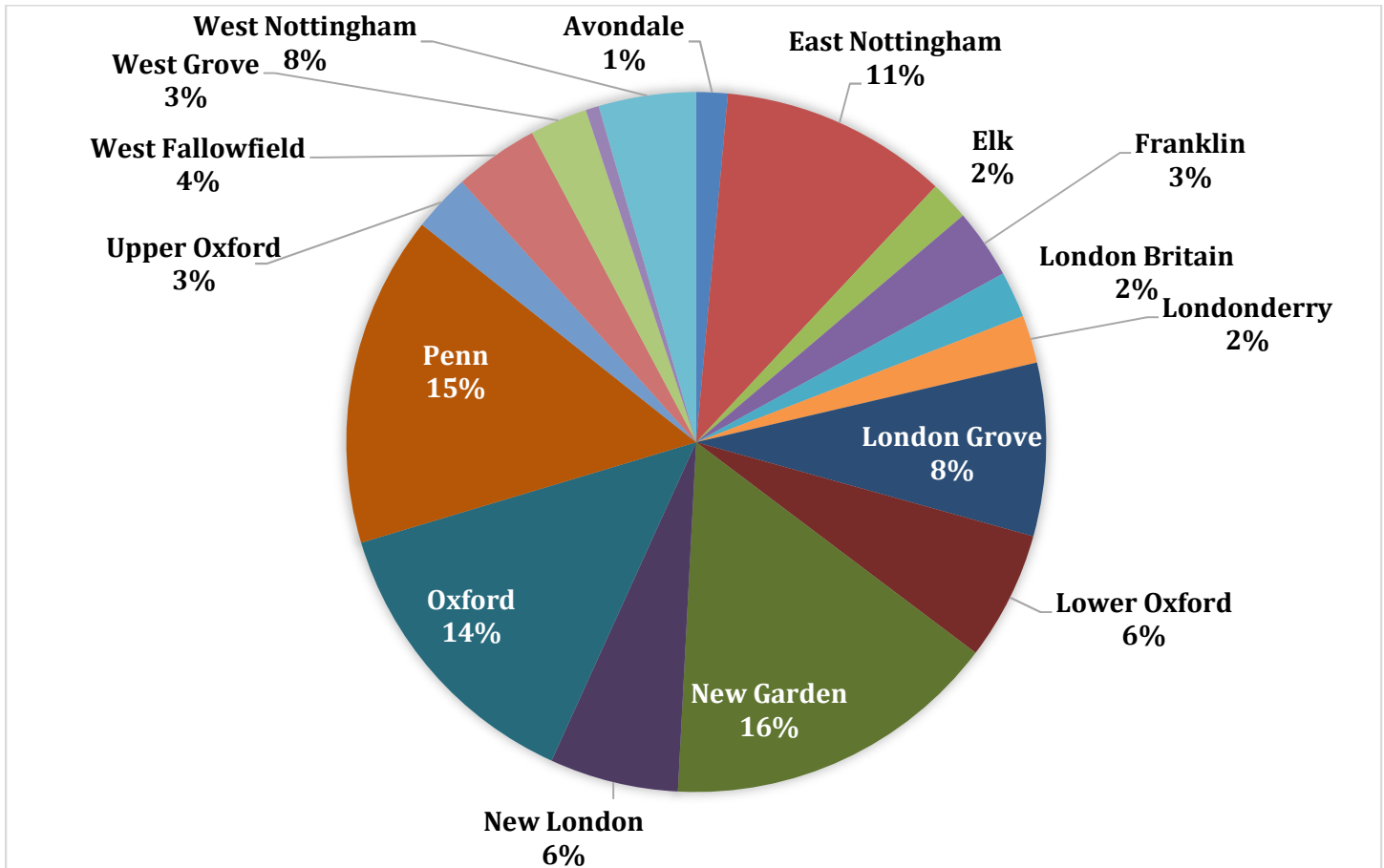

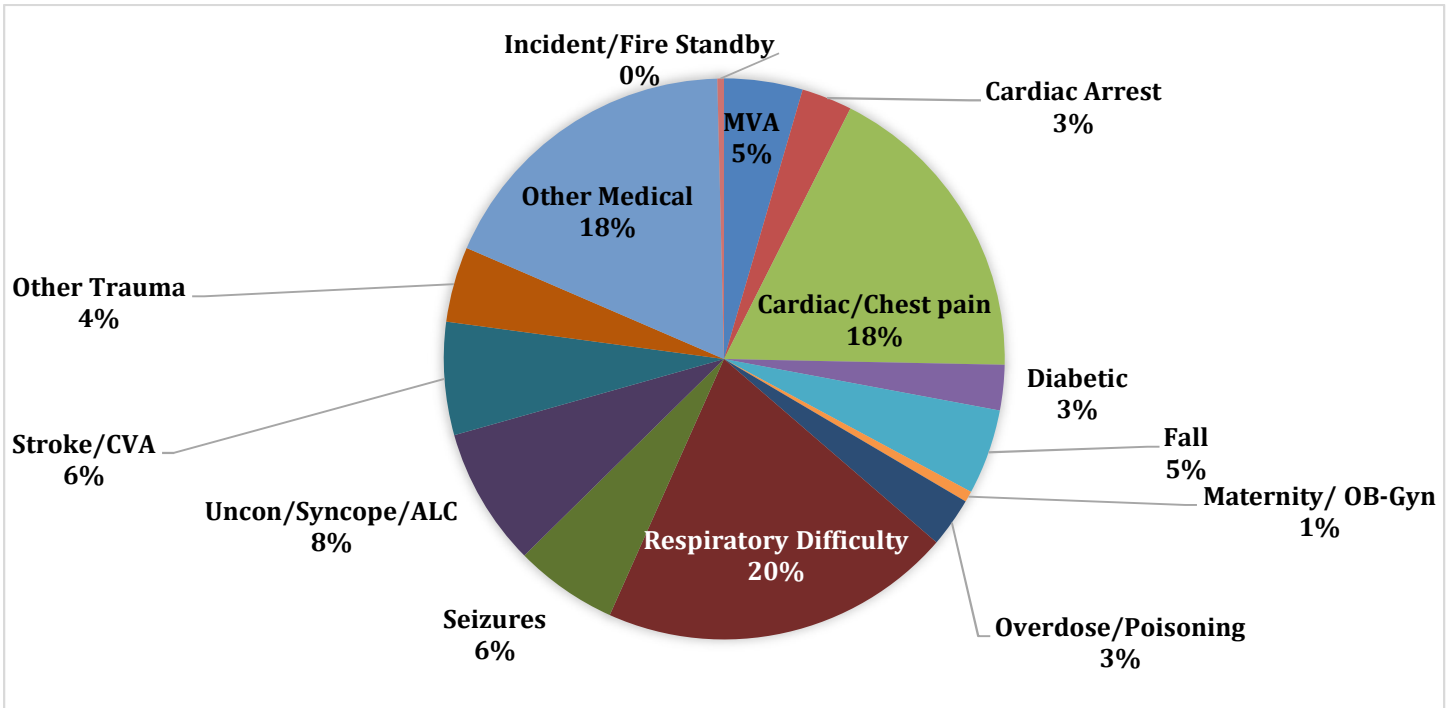
INCIDENTS HISTORICAL (CY22 numbers are extrapolated from YTD data)



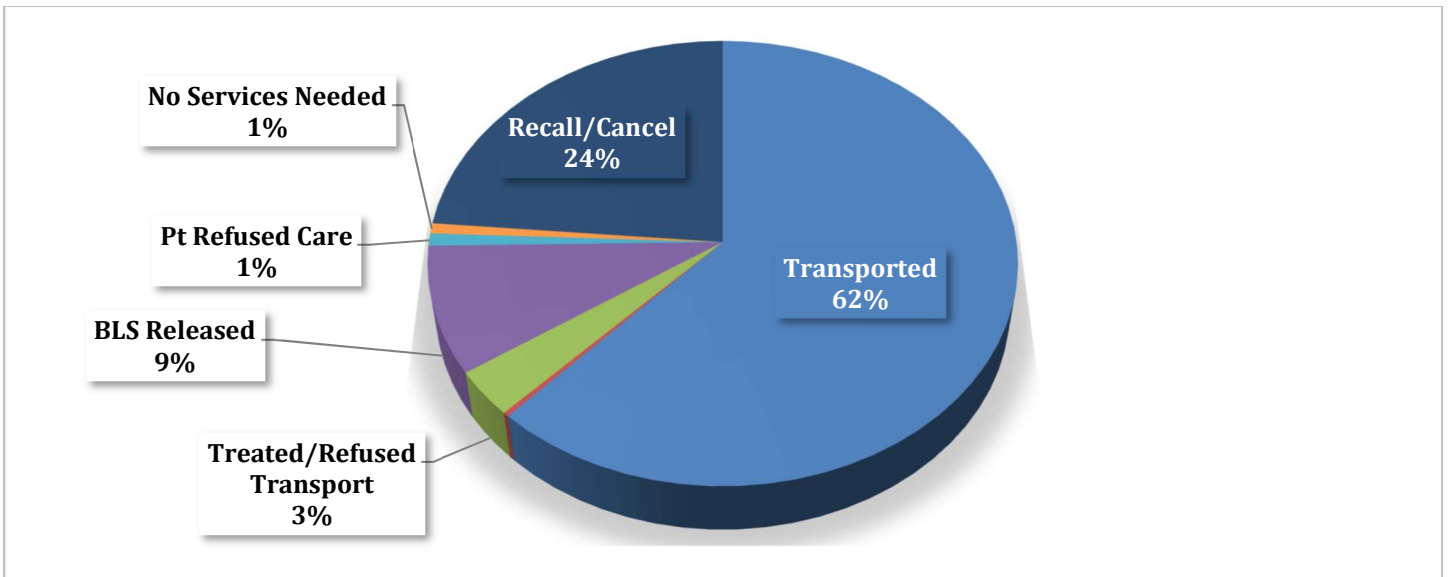
INCIDENTS BY MUNICIPALITY-YTD 2022



INCIDENTS BY DISPATCH NATURE- YTD 2022



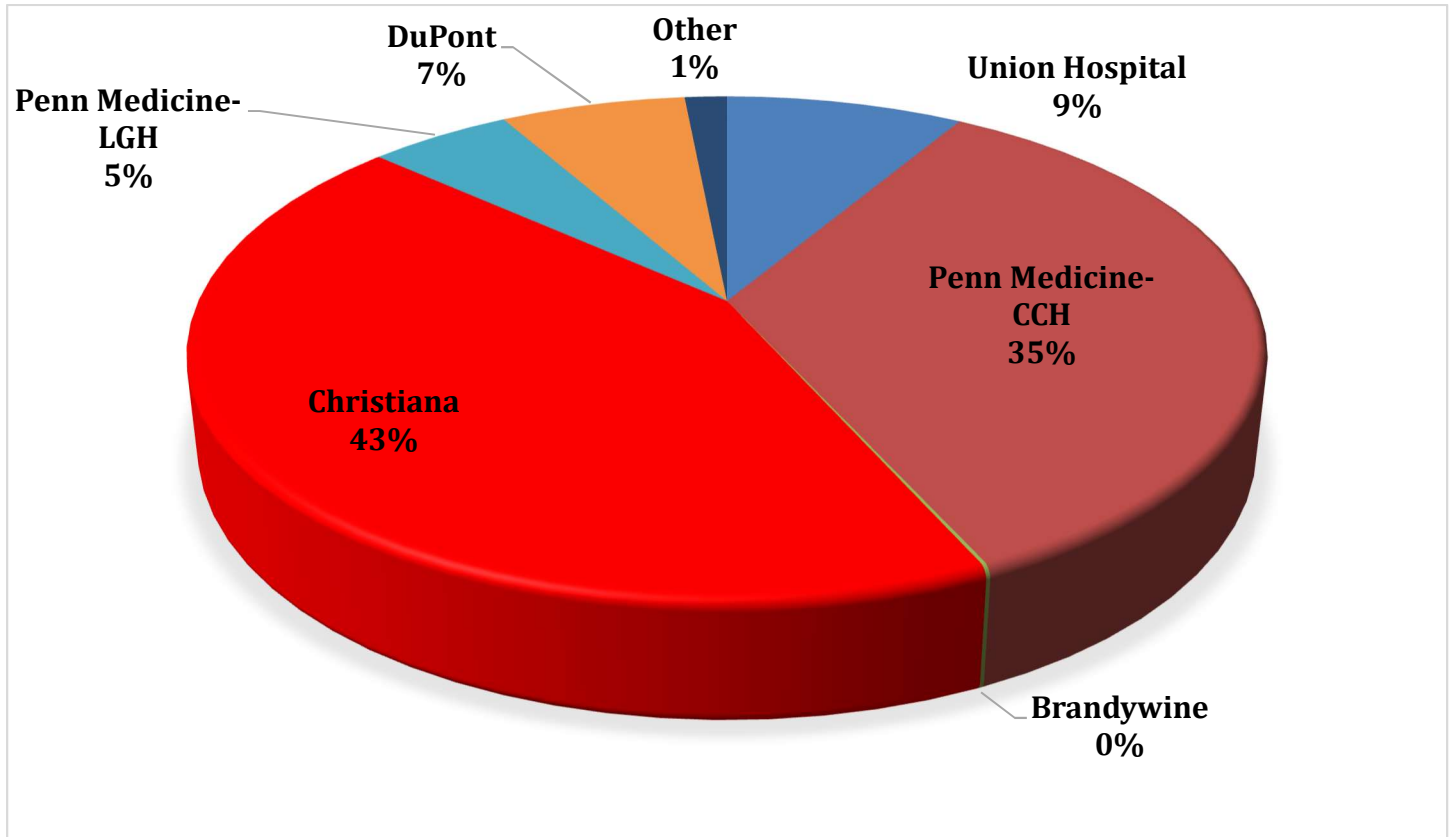
INCIDENT OUTCOME-YTD 2022



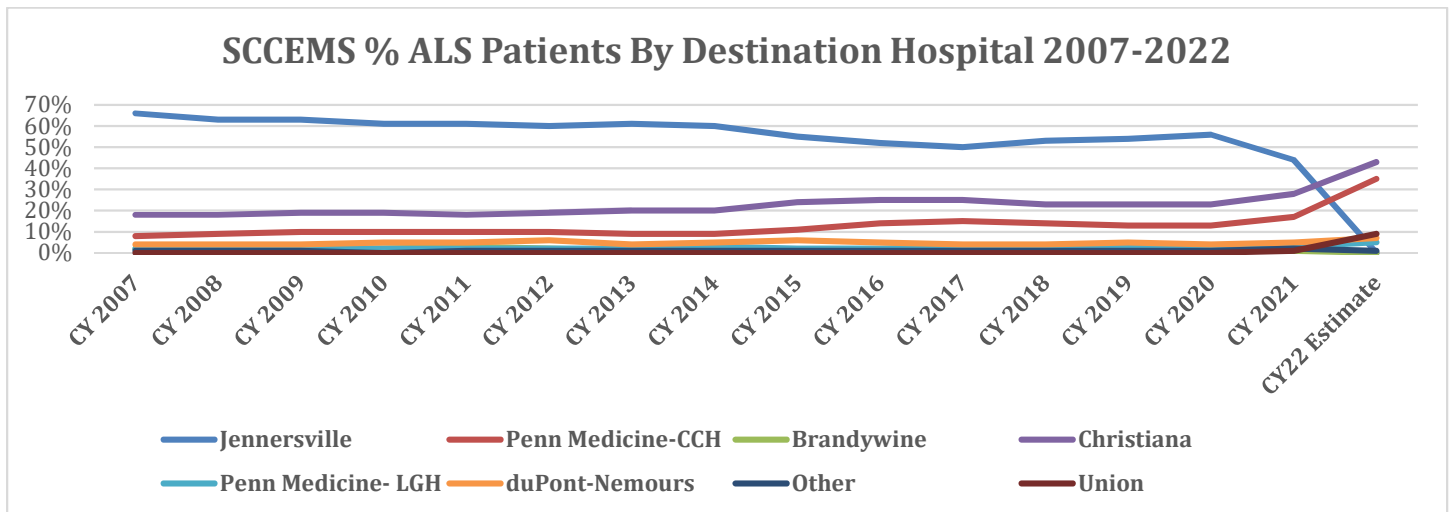
OPERATIONAL TIMES- MAY 2022

- SCCEMS has received an extension from Tower Health to remain in the quarters at the closed Jennersville Hospital until 30 September. They have added a 30 day early termination clause. We suspect that was due to the possibility that the facility would be sold.

We are awaiting the review and decision by Chester County regarding the Penn Township Grant request to fund a new building for MEDIC 94. That decision is expected by 1 July.

150 days in, we have been able to summarize the operational impact of the hospital's closing.

18% increase in call volume

14% of dispatches handled by 3rd staffed unit staffing

10% increase in patients transported

20% increase in average call time

63 vs 76 minutes

32% increase call time/ transport

85 vs 112 minutes

40% increase vehicle mileage
