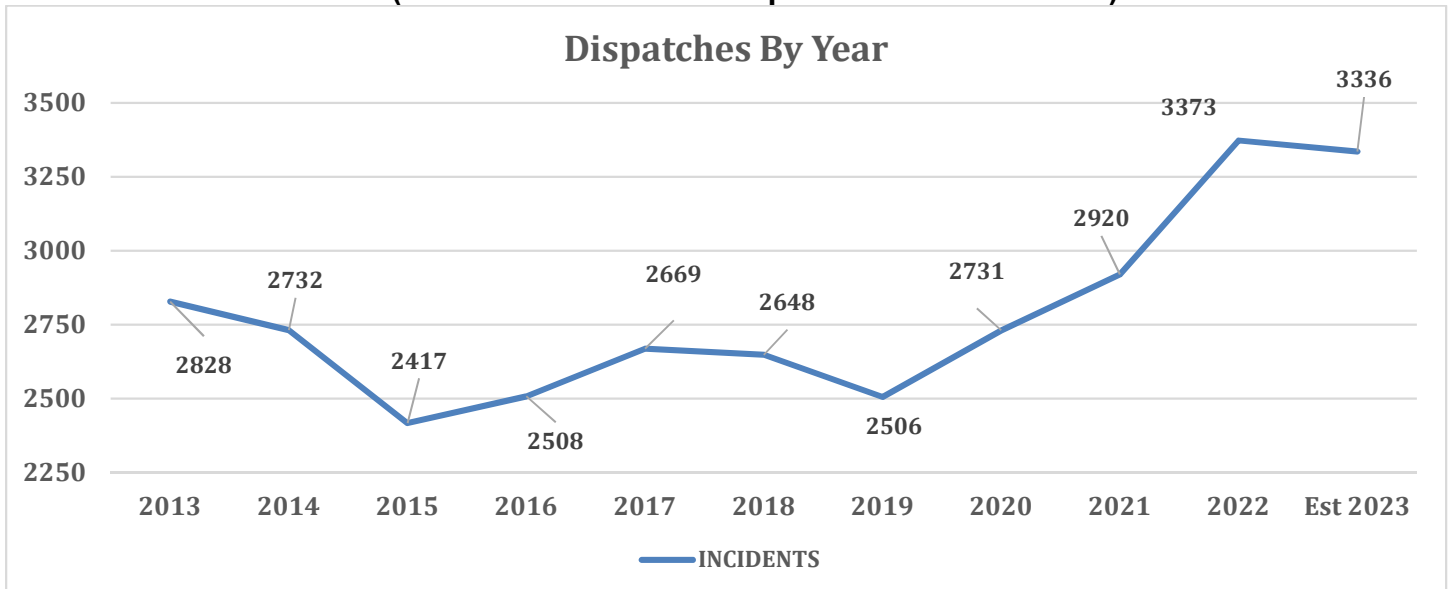

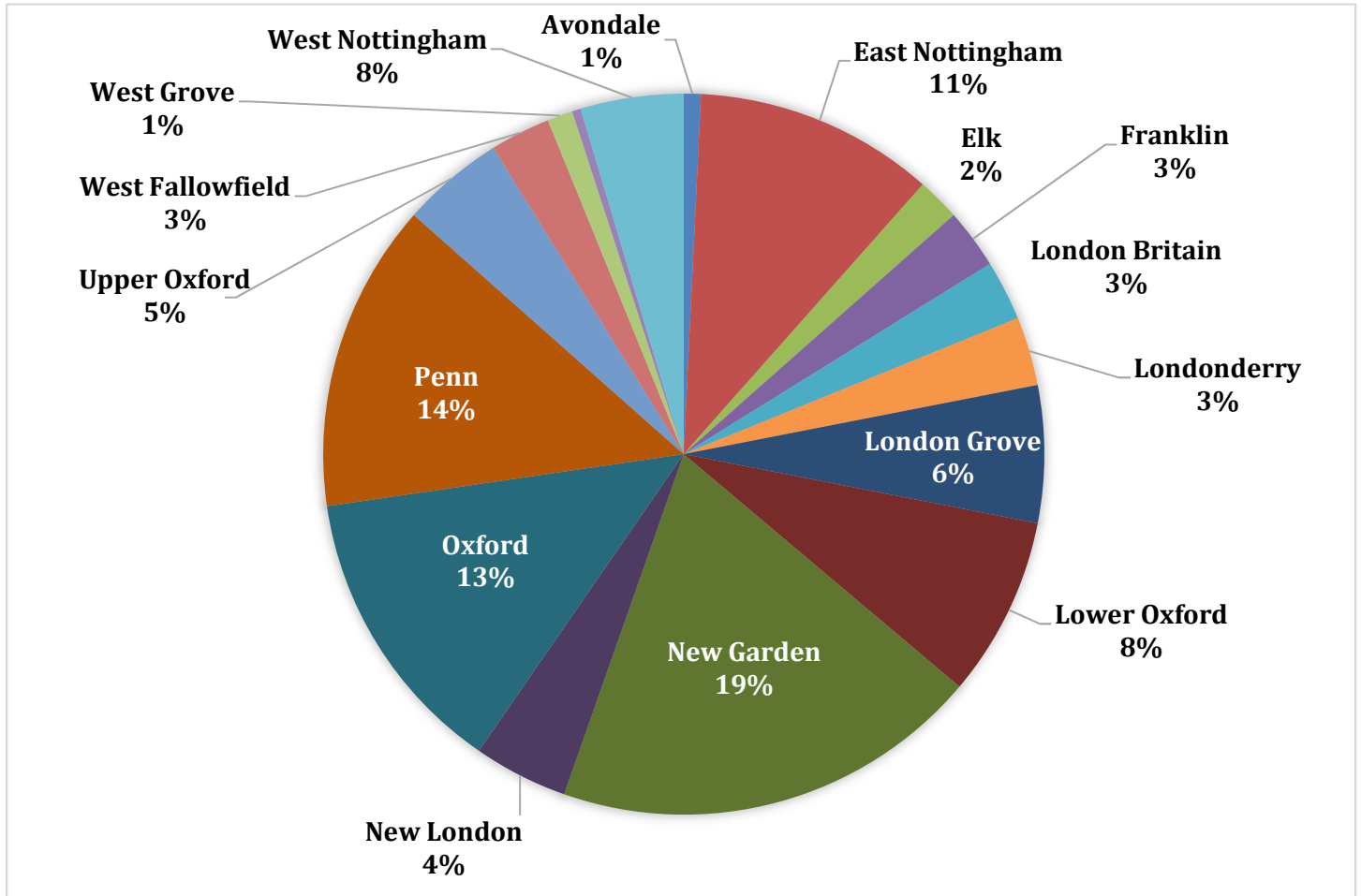

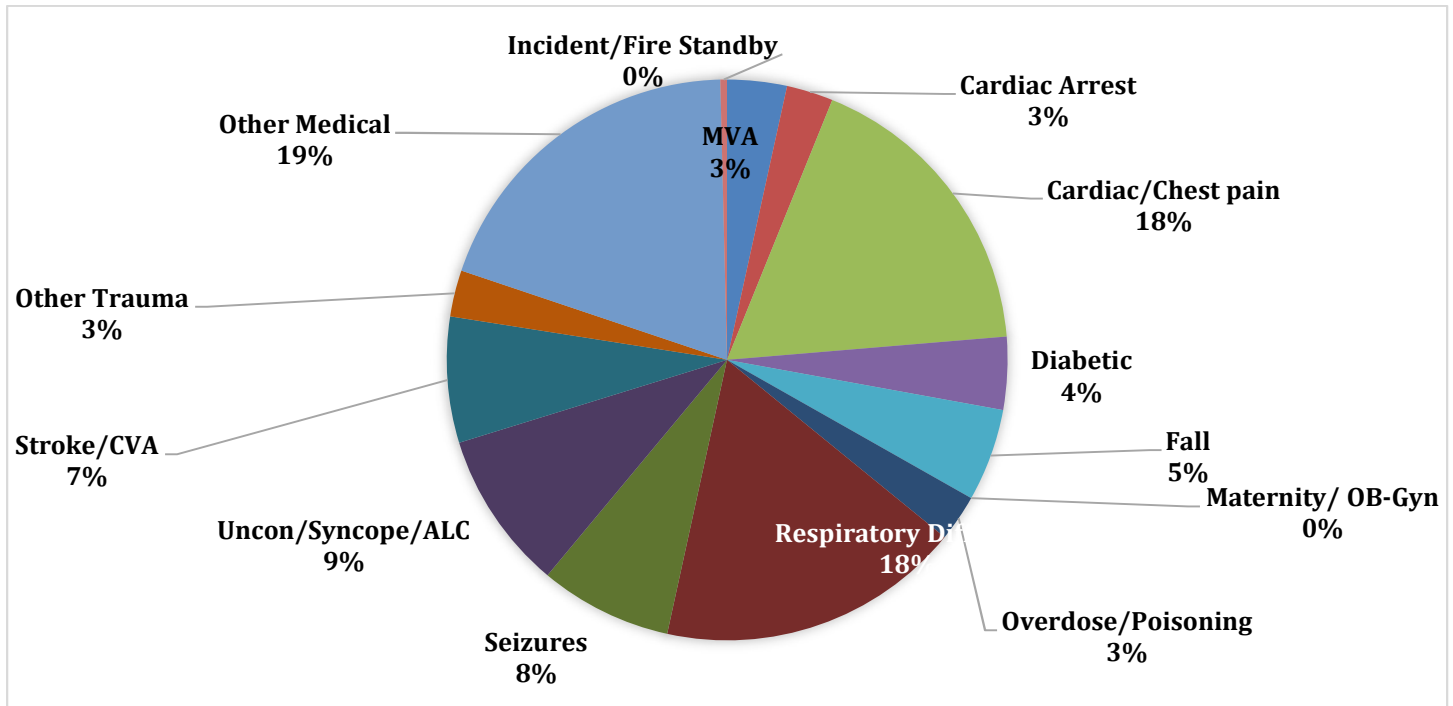
INCIDENTS HISTORICAL (CY23 numbers are extrapolated from YTD data)



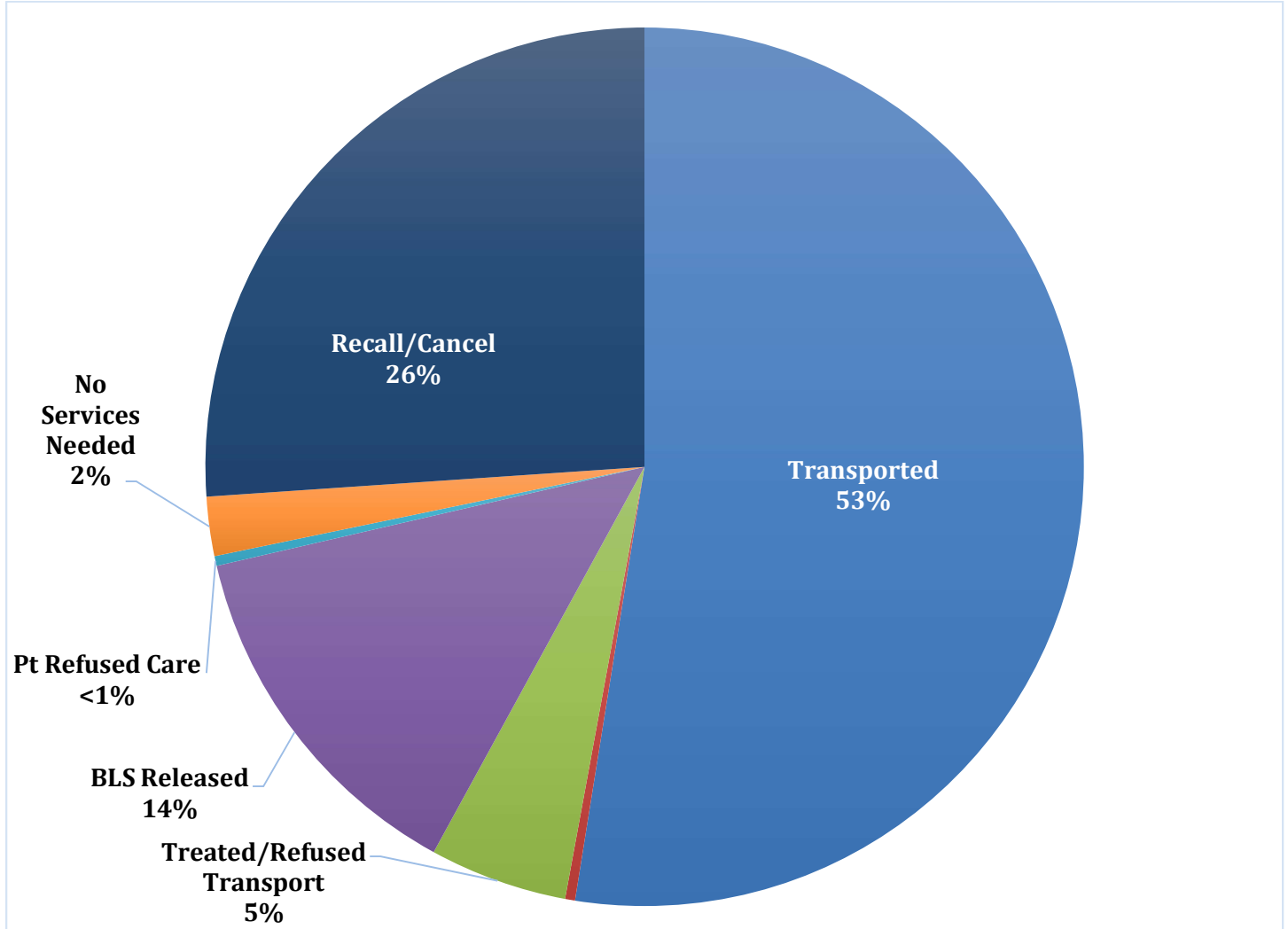
INCIDENTS BY MUNICIPALITY-YTD 2023



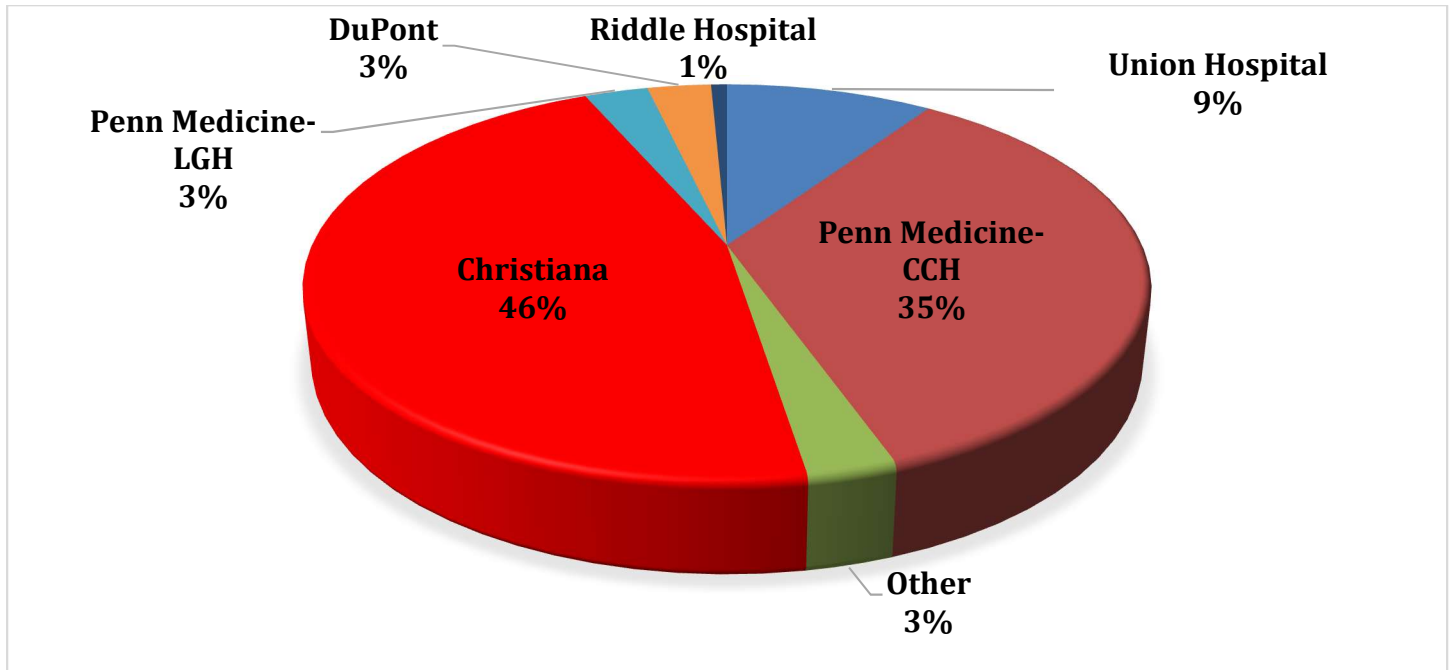
INCIDENTS BY DISPATCH NATURE- YTD 2023

- **CHRISTIANACARE-** There is no timetable for the opening of the ChristianaCare-West Grove Campus. It is expected that an announcement of a timetable for reopening will be announced in the 1st Quarter of 2023. Our expectation is the emergency department will not reopen until 2024. SCCEMS continues to operate from the closed hospital. CEO Bob Hotchkiss has had ongoing communications with the ChristianaCare leadership.
- **CHESTER COUNTY-PENN TOWNSHIP ARP GRANT**—Penn Township and SCCEMS leadership have held multiple meetings regarding the future MEDIC 94 station at the corner of Old Baltimore Pike and Jenner’s Pond Road. This project will receive \$850,000 from Chester

County's American Rescue Plan Grant funding. Project completion is scheduled for the end of 2024. The initial discussions involve lease details and the initial station design

- **2022 SCCEMS ANNUAL REPORT-** The March Municipal Report will be our annual operations and financial report to the community. We will provide all municipalities with electronic copies and a link to the document will, be placed on our website medic94.org
- **LONDONDERRY TOWNSHIP ARP GRANT-** *Thank you to Londonderry Township* for the \$31,000 grant from their ARP funds to benefit MEDIC 94. These funds will be used to purchase new personal protective equipment for our paramedics as well as a second ventilator, IV warmers and other life-saving equipment.



OPERATIONS NEWS

- **POWER TRUCK-** We continue to staff a 3rd paramedic unit 7 days a week from 9am to 7pm, our peak call time. The addition of this additional provider helps maintain paramedic coverage in the district due to increased transport time and hospital waits. That unit has been staffed over 70% of the time and has been responding to over 15% of our dispatches.
- **OUTREACH-** We are back out doing our community education and outreach programs Paramedic Sergeant Jake Barnes is leading this effort. If you would like a hands Only CPR, Stop the Bleed, Paramedic Demo at your municipal event, please contact Jake at jbarnes@sccems.org.
- **NEW VEHICLE-** We will be placing into service a new 2023 Ford Explorer paramedic unit the week of 27 February. Purchased with funding provided by Senator Carolyn Comitta, the Pennsylvania Office of the State Fire Commissioner, and the Oxford Area Chamber of Commerce, this new truck replaces our 2014 Explorer that has accrued just under 160,000 miles in its 8 years of service. The new truck will undergo an equipment inspection by the regional EMS office before being placed in service at our Jennersville station. Thank you to New Holland Ford, 10-8 Emergency Vehicle Service, and Fitch Graphics and Design for putting the final product together over the past 45 days. These 3 vendors have completed the past 10 vehicles for SCCEMS. Fitch Graphics has been professionally lettering our vehicles for over 25 years.
