New! - Certified Commercial Contract Manager (CCCM) Practice Test

An educational tool is now available for NCMA's CCCM certification exam. A 150-question CCCM practice exam is now available covering Articles 1–9 of the Uniform Commercial Code. Designed to emulate the actual exam experience, the practice test can be used to gauge strengths and weaknesses to help candidates pass the NCMA certification exam.

NCMA Early Membership Renewal Savings

NCMA Headquarters now offers a \$15 discount for any member who renews **two months ahead** of their regular renewal date. For example, if your membership renewal date is May 31, 2019, you can claim your early renewal discount if/when you renew **between March 1**, **2019 but not later than March 31, 2019**. Because of temporary technical issues, this discount is NOT currently available if you use the on-line system. However, if you call Member Services at 800-344-8096 X 4 to talk with a "real" person, you can complete the transaction in less than five minutes and save \$15 on your renewal.

Even though NCMA HQ currently sends e-mail renewal reminders, your JAX Chapter will start sending renewal reminders **three months ahead** that explain the savings procedures.

JAX Chapter By-Laws Require Membership Approval

Chapter By-Laws provide policies and procedures to efficiently operate a chapter for the benefit of the entire membership. From time to time, situations change and the rules must be amended. The Chapter Executive Council recently completed its review of the existing By-Laws and developed the February 2019 revision. Some of the changes require general membership approval.
