### Then and Now - Monthly Member Highlights

This month I had the pleasure to interview **William Swan** and **Blake Anderson**, both gentlemen who are board members of the Jacksonville Chapter. As you read through the interviews you will see that as contract professionals the career field is vast in experiences and career paths. I hope you enjoy reading about these two professionals as I have enjoyed learning about them.

William H. (Bill) Swan, Jr., CPCM (Ret), Fellow Joined NCMA 1981 Blake Anderson
Co-Chair Membership 2023-2024
Joined NCMA 2008

- 1. When did you join NCMA? March 1981(42+ years ago). I was a member of the "National" Chapter my first three years then joined five other chapters including two for which I was a "Founding Father" in 1988-1990. I affiliated with JAX Chapter in October 2006 and have held every office except President since then.
- 2. How long have you been in the contract profession? I started in July 1975 and retired in June 2005. My last employer asked me for assistance over a nine-month period following my retirement.
- 3. What was your first contract job? Procurement Systems Manager at Shaw AFB. The Air Force had just fielded

- 1. When did you join NCMA? I first joined NCMA back in 2008, as part of a college internship program. From there, I have been engaged in multiple local chapters to include Washington, DC; Tysons, VA; Charleston, SC; and now Jacksonville, FL.
- 2. How long have you been in the contract profession? I have been in Contracts for over 14 years, 10 of which has been full time.
- 3. What was your first contract job? I started as a summer intern on my Summer and Holiday breaks from college. At the time, my company was switching from a 100% paper/Binder Contracting filing system, to a very crude electronic

a contract writing system called Customer Integrated Automated Procurement System (CIAPS). I had to quickly learn the details of the system then train the other 40 people in my office. I developed a reputation as the "go to" guy for CIAPS questions and worked closely with my higher HQ to brainstorm problems and better procedures.

- 4. What's your favorite part of the contracts industry? I always tried to have a clear idea of what supplies, services, or other projects I was buying before I started building the procurement package. I worked closely with customers to make sure my contract documents would fully satisfy their requirements. Being able to save money on major projects without compromising the key elements or requirements was also fulfilling.
- 5. What's one challenge you occasionally or regularly faced in contracts? Customers who insisted they knew all the details of the procurement package and refused to listen to explanations of why certain procedures were required. In almost all cases, I was able to convince them we knew what we were doing.
- 6. What was/is the biggest achievement you experienced during your career? Actually, there were several: I was a contracting officer at Pentagon Renovation Project responsible for relocation of personnel and equipment in two of the five "wedges" of the building. I

contract management system (CMS). So I had the "envious" task each summer to help migrate all the paper documents into the new CMS.

- 4. What's your favorite part of the contracts industry? Contracts as a field is vast. There are core principles and competencies that once you pick up, can be applied across the gamut, and facilitate transitioning across multiple customers, product lines, and Government/Commercial agencies. A common saying in our company is nothing gets done without a Contract.
- 5. What's one challenge you occasionally or regularly face in contracts? People in our field regularly get caught in the trap of having to "win"; whether it be in a customer negotiation, project planning, or proposal. I try and remove myself from that thinking, and evaluate the situation from both a probability perspective, and reach an outcome that is best for both parties.
- **6.** What is the biggest challenge you experienced during your career? Having patience. In my career, I have frequently wanted to "run and fly" on my own before I was really ready. Unlike a lot of other careers out there, Contracts is a lot of on-the-job training where you learn from you experiences and are measured by the battle scars you have earned.
- 7. How has your role changed over that time? My entire career has been at one Major Defense Contractor. In that one

was a first responder to the Pentagon attack on 9-11- 01 and spent 45 days in the Military District of Washington Emergency Operations Center as the Contracts Manager. My contributions to HQ Army Contracting Agency (ACA) attainment of ISO 9001 certification; I was the ACA Customer Service Excellence Manager and oversaw implementation of the Contracting module of the Interactive Customer Evaluation (ICE) system at Army installations worldwide.

- 7. How has/did your role change over that time? Throughout my career, I really enjoyed training and mentoring my coworkers and subordinates as well as developing policies and procedures to streamline and improve procurement practices. I made the shift from worker bee to team leader then manager.
- What 8. changes have/did you experience that truly stick out? Transition from the Armed Service Procurement Regulation (ASPR) in 1975 to the Federal Acquisition Regulation (FAR) in 1984 flattened the learning curve for new employees and standardized policies and procedures across the federal government.

Corporation, I have moved around a lot and had the opportunity to work with many different customers, product lines, and Contacting methodologies.

8. What changes have you experienced that made an impact in your career? In 10 years, I have physically moved four (4) times to support new customers, get exposed to new products and see how different parts of the business does contracting. I put myself on this self-developed rotation. I think establishing these rotational assignments for oneself is vital to early development within the field. Each experience adds another tool in the Contracts Professional's toolbox.
