CPARS is relied on extensively by Federal contracting officers to review contractor past performance in order to make informed business decisions when awarding new contracts/orders. In this fast-paced 90-minute webinar, participants will be provided with the history of past performance in Federal contracting, an overview of CPARS, the types of evaluations used in CPARS, reporting frequency, and Federal Acquisition Regulation (FAR) regulations.

Changes to NCMA Early Renewal Discount
