NOTICE OF PUBLIC HEARING
VILLAGE OF RAVENA

THE VILLAGE OF RAVENA BOARD WILL HOLD A PUBLIC HEARING ON JULY 20, 2021 AT 6:00 P.M. AT THE VILLAGE OF RAVENA MUNICIPAL BUILDING LOCATED AT 15 MOUNTAIN RD., RAVENA, NY 12143 FOR THE PURPOSE OF HEARING PUBLIC COMMENTS ON THE VILLAGE OF RAVENA'S COMMUNITY DEVELOPMENT NEEDS, AND TO DISCUSS THE POSSIBLE SUBMISSION OF ONE OR MORE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) APPLICATIONS FOR THE 2021 PROGRAM YEAR. THE CDBG PROGRAM IS ADMINISTERED BY THE NEW YORK STATE OFFICE OF COMMUNITY RENEWAL (OCR), AND WILL MAKE AVAILABLE TO ELIGIBLE LOCAL GOVERNMENTS APPROXIMATELY \$40 MILLION FOR THE 2021 PROGRAM YEAR FOR HOUSING, ECONOMIC DEVELOPMENT, PUBLIC FACILITIES, PUBLIC INFRASTRUCTURE, AND PLANNING ACTIVITIES, WITH THE PRINCIPAL PURPOSE OF BENEFITTING LOW/MODERATE INCOME PERSONS. THE HEARING WILL PROVIDE FURTHER INFORMATION ABOUT THE CDBG PROGRAM AND WILL ALLOW FOR CITIZEN PARTICIPATION IN THE DEVELOPMENT OF ANY PROPOSED GRANT APPLICATIONS AND/OR TO PROVIDE TECHNICAL ASSISTANCE TO DEVELOP ALTERNATE PROPOSALS. COMMENTS ON THE CDBG PROGRAM OR PROPOSE PROJECT(S) WILL BE RECEIVED AT THIS TIME. THE HEARING IS BEING CONDUCTED PURSUANT TO SECTION 570.486, SUBPART I OF THE CFR AND IN COMPLIANCE WITH THE REQUIREMENTS OF THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974, AS AMENDED.

THE VILLAGE OF RAVENA, VILLAGE HALL LOCATED AT 15 MOUNTAIN RD., RAVENA, NY 12143 IS ACCESSIBLE TO PERSONS WITH DISABILITIES.
