

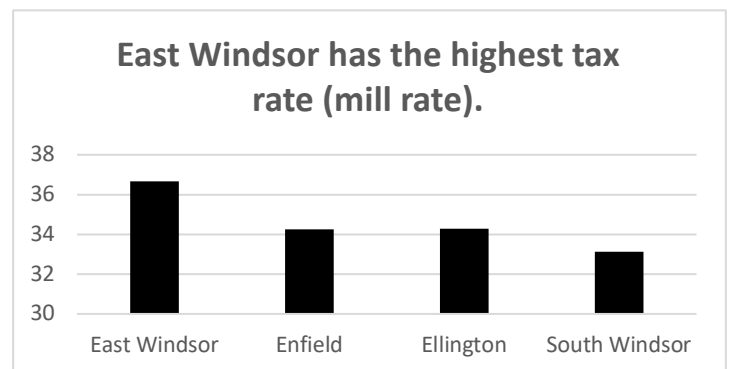
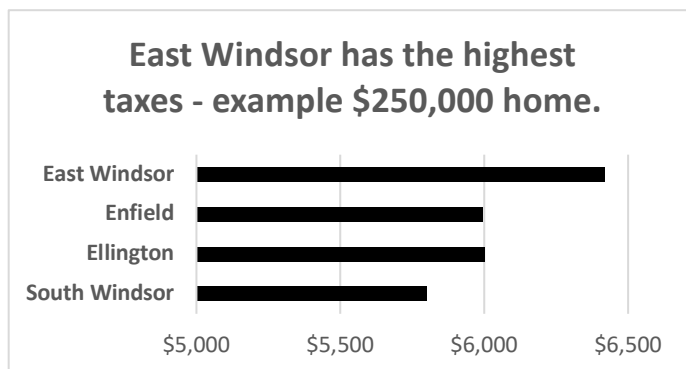

The past four years have produced high taxes, a decline in economic development, lost businesses and an invasion of Industrial Solar throughout East Windsor.

- Little progress is evident, even after spending \$16 million in pandemic assistance from state and federal sources.
- The grand list is FLAT indicating no net economic development. A growing grand list is a sign of vitality/progress. A stagnant grand list leads to decline in public services and an increase in taxes.
- Throughout Broad Brook & Warehouse Point, you will see empty storefronts and buildings.
- We now have 1000+ acres of Industrial Solar complexes, providing minimal taxes and destroying our farmland and the quality of life of those that live near these sites.
- The historic Broad Brook Mill, which was contaminated, was removed from federal Environmental Protection Agency oversight by the First Selectman without any public input.



East Windsor pays the highest taxes of the four towns. For a \$250,000 home, EW pays \$6,419. SW pays \$5,800. Ellington pays \$6,002. Enfield pays \$5,996.

Our Plan is all about the right kind of progress. Fostering business growth to lessen the tax load on our homeowners. Strict financial discipline and smart spending to maximize community benefits and lower taxes. We're fighting to help our farmers and to preserve our historic buildings because that's what makes East Windsor special.

Let's be candid – taxes in East Windsor increased despite the millions of dollars of pandemic relief. There's little to show for that money, businesses and local shops are struggling and families are still hurting. We cannot continue like this; it is time for change.
