

## 2020 ESTES PARK HOLIDAY WINE FESTIVAL FOOD VENDOR APPLICATION

## **Greetings!**

You are invited to complete this vendor application for THE 2<sup>nd</sup> ANNUAL ESTES PARK HOLIDAY WINE FESTIVAL on Saturday and Sunday Nov 28<sup>th</sup> and 29th, 2020. The Estes Park HolidayWine Festival will feature wineries, demonstrations, artisans/lifestyle vendors, entertainment and delicious cuisine. The festival will be held at the Estes Park Events Center in Estes Park, Colorado. We plan to limit the number of Food Vendors based on space and want to make sure vendors complement the local, wine or food categories. Applications must be received (with payment) by September 30, 2020. No refunds after Oct 31, 2020. The EPHWF committee is looking for food vendors to complement the high quality of Colorado wines and is open to all restaurants with location(s) in Northern Colorado. Vendor selection will be based on the ability to provide a well-balanced vending area, and if more than one vendor applies with the same type of product, preference will be given to the vendor who applied first. Vendor space is limited, as well as vendor booth space electricity. There will be an added \$25 charge for electricity.

- Early set-up is encouraged and will be Friday. Regular set up begins Saturday morning beginning at 7 am and must be complete by 10:00 am. Assistance may be provided!
- You must stay open for the duration of the event on Saturday and Sunday Nov 28<sup>th</sup> and 29th from 11 AM 5 PM on Saturday and 11AM-4PM on Sunday.
- Site selection is based upon a 'first come-first serve basis' and will be assigned with application and payment of fee.

Each vendor will be supplied with a 10' x 10' space. Vendors are required to bring a professional sign with name of their company and prices visible, to be placed at their booth. Please fill out the information below and return it with application fee to:

Please include the application fee of \$275.00. You are responsible to furnish your own pop-up tent. Tents may be rented at an additional cost. Your check will be refunded should your company not be selected.

Please provide below a brief description of your restaurant and cuisine you offer.				

- Tent. Tent space with protective wind and rain resistant roof. Vendors should prepare for any type of weather, particularly wind and rain (including late afternoons thunderstorms). Tent tie-downs (i.e....water jugs) are <u>required</u>. NOTE: Tents larger that 10X20 need to be fire retardant and approved by Estes Park Fire Department.
- **Pets.** Pets are not allowed on the festival grounds. Service animals, which are registered with the State of Colorado and used for the purpose of aiding a disabled individual, are exempt.
- **Product Restrictions.** Acceptance is based on the understanding that Vendors will sell only those items listed on their applications. Additional items may NOT be sold without the event organizers expressed consent.
- Sales Taxes. Vendors must have either a general Colorado Tax License or a Colorado Single or Multiple Event Sales Tax License. - Each vendor is responsible for the collection and payment of sales tax to the State of Colorado as required.
- Vendor needs to have proper insurance and must provide a copy of its policy or certificate showing necessary coverage. \*

minimum of \$1,000,000 policy limits per occurrence for Bodily Injury and Property Damage, and an aggregate limit of at least \$2,000,000 CSL. Policy shall reflect coverage for Premises/Operation and Products Liability). The Policy shall name the Town of Estes Park, Estes Park Holiday Wine Festival and The Bowers Group LLC as additional insured's for the term of the event. You must have proof of insurance.
