## PERMIT HOLDER REQUIREMENTS

### SPECIAL EVENT PERMIT HOLDER REQUIREMENTS

General: A permit may be issued contingent upon the following requirements. Please read carefully and initial or check each section and sign at the bottom. The permit applicant shall be responsible for the following items mentioned herein:

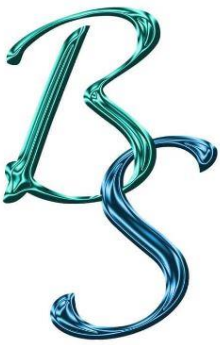
- SITE:** A site map showing locations of tents, vendors, and cooking must be provided to the Bureau at time of application. A vendor requirements checklist must be completed by each vendor and submitted to the Bureau prior to the event or to the inspector at the time of inspection.
- TENTS:** All tents shall have a Flame Retardant or Resistant Certificate (Tag or Paperwork) on-site and/or submitted with the application. A minimum 10 ft. of clearance between rows of side-by-side tents shall be provided (walkway). Shade canopy's smaller than 10x10 without sides may be approved for use on a case by case basis. No smoking in any tent.
- COOKING TENTS:** Tents up to 20x20 are allowed to have (APPROVED APPLIANCES) along the edges of the tent. LP gas tanks must be secured in place (max cap 20lbs.) Fire Extinguisher must be readily available, see below. Any LP tanks larger than 20 lbs. shall be secured 10 ft. from tents with gas lines secured. All cooking vendors shall have a 10ft. separation from all other non-cooking tents and/or vendors. NO DEEP FRYING UNDER TENTS!
- LARGE TENTS:** For tents 20x20 or larger, If enclosures (sides) are used, exits shall have exit signage. If the tent is used at night, exit signs shall have attached emergency lighting and be AC and DC powered. All tents 20x20 or larger must have "NO SMOKING" signs.
- FIRE EXTINGUISHERS:** Every vendor is recommended to have at least one extinguisher. At least one currently certified and tagged, or within one year of manufacture date, extinguisher is required every 75' along event walkways. All vendors who are cooking and/or using generators are required to have at least one 5lb ABC currently certified and tagged, or within one year of manufacture date, (2A10BC) extinguisher. All vendors who are deep fat frying are required to have at least one currently tagged Class K extinguishers.
- COOKING:** All food cooking concession trucks, trailers and structures of rigid construction must have a currently tagged commercial ventilation, and extinguishment/suppression system if required per the FFPC and NFPA 96.
- OPEN FLAMES:** All open flames, fireworks or fuel-fired lighting or devices are prohibited under any tent or similar enclosure unless prior approval from the Bureau is obtained.
- ELECTRIC:** wiring and lighting shall be free of damage. All electrical equipment shall be isolated from the occupants/general public in a safe manner. All electrical connections, switches and fuses shall be in secured in approved enclosures per the electric code NFPA 70.
- EMERGENCY EGRESS:** For every 100 ft. row of tents, an emergency exit walkway is required 5' feet or larger.
- SEATING:** Seating and chair arrangements shall be approved by the Bureau prior to the event and have a minimum of 3ft. wide walkways to all exits in the tent. Tents with an occupant load of over 49 are required to have at least 2 exits. Seats in assembly occupancies accomodating more than 200 persons shall be securely fastened to the floor, except where fastened together in groups of not less than three.
- STORAGE:** Use or handling of flammable liquids or gases shall be prohibited at the site unless specifically approved and inspected by this Bureau.
- FLOOR/DECOR:** No hay, straw, shavings or similar materials shall be permitted to be used within any structure, tent or canopy. Exceptions: Pre-approved flame retardant treated materials or livestock bedding/fodder.
- GENERATORS:** Generators shall be on level ground, secured, and safely arranged and isolated from the occupants/general public. Exhaust shall be directed away from combustible material(s), people and/or animals. Spare fuel shall be stored in an approved container at a safe distance from generator. NO HOT FUELING! Fire extinguisher required.

Code References: Florida Fire Prevention Code (FFPC), NFPA 1, NFPA 96, NFPA 70, NFPA 101, & NFPA 102.

- Any vendor(s) found not complying with the referenced Fire Prevention & Life Safety Codes may be issued a cease and desist order by the Fire Marshal which will remain in effect until compliance is made.

- I must clean my display area and remove trash at the end of each day.
- I will not swap/trade booth assignments.
- I understand there can be NO open flames or candles or any other similar materials for safety reasons.
- I understand there will be NO Smoking permitted indoors. Outdoor smoking is permitted in designated areas only.
- I (we) agree to hold harmless INDIAN RIVER COUNTY FAIRGROUNDS or their agents, management, promotors, volunteers, successors, assigns, or subcontractors from any and all liability for damage, injury and loss to any person or goods which may occur in the space provided to me on show property, suffered at the show, participating in, or returning from this event. These include damage during set-up and dismantle of exhibit.
- I am responsible for my own insurance if needed.
- I understand there will be NO pets FROM VENDORS (with the exception of service animals).
- I understand I am responsible for any lost or stolen items.
- I will send a picture of my display from a previous event. I understand there will be only one consultant from each MLM company, but different crafters ,VENDORS may have similar items and the picture of my display will help the event coordinator spread out items that are similar in construction.
- I acknowledge all booth fees are non-refundable no matter the reason unless the event is cancelled by state, county, city, or facility management.

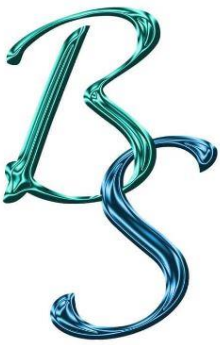
