The credit terms of this supplier are Net 30 days, and the subject company would pay within 42 days. The average purchase volume was reported at \$10,000 per month. No returned cheques are reported. The account is rated as satisfactory so far.

The Association confirmed with the company ELECTRONICS INC., 333 Louis St., Montreal, Quebec, tel. 514 010-0000, a commercial account opened under the name of the subject company for over 4 years. The high credit was reported at \$4,000. The balance due was reported at \$1,987 at the time of our verification. The credit terms of this supplier are Net 30 days, and the subject company would repay on average within 30 to 40 days. No returned cheques are reported. The average purchase volume (monthly or yearly) was not reported at the time of our verification. Rated as a good client.

Financial Data

The fiscal year of the company ends on November 30th of each year. The outside accounting firm appointed to prepare the subject company's financial statements is TTT & ASSOCIÉS, Montreal, Quebec, tel. 514 100-0000.

The Association contacted one of the subject company's official spokespersons, its president Mr. Paul Kkkkk, to obtain certain financial data from their most recent financial statements available.

According to the financial data forwarded by Mr. Kkkkk, the subject company achieved as of November 30, 20XX gross revenues of \$923,790 with net income after taxes of \$125,512.

As of November 30th, 20XX, the company had total assets of \$297,801 less total liabilities of \$191,022, leaving a positive shareholders' equity of \$106,779.
