Ada County USBC Local Women's Championship Tournament Rules

1. **Bowling Center:** All bowling will be conducted at Westy's Garden Lanes, Garden City, Idaho
2. **Eligibility:** The Ada County USBC Association tournament is open to USBC members in good standing holding a current 2025-2026 membership card from the Ada County USBC at the time of the tournament. If a bowler wishes to bowl and is not a member of the Ada County USBC, the bowler must purchase a local card, in the amount of \$8.00, and fill out the proper membership at that time. USBC membership cards must be shown to a tournament official upon check-in for the bowler's first scheduled event.
3. No entry money will be refunded if it is discovered that a team or individual has failed to comply with all USBC eligibility requirements.
4. Entrants may bowl multiple times with the understanding the highest place is the only cash prize they can win. (If a bowler places more than once they will **ONLY** receive the highest payout.)
5. Handicaps in each event will be based on 90% of 220 pins.
6. Prize Fund will be returned based on a minimum of 1 in 10 entry ratio.
7. The highest league certified average of 21 or more games in the 2024-2025 season must be used. If no 2024-2025 average is available, the highest current average of 21 or more games as of 12:01 a.m, January 1, 2026 must be used. If the entrant does not have a 21-game average by January 1, 2026, but does have 21 games by the closing date, the Tournament Director has the option to use that average. If none of those conditions apply, then the bowler must bowl scratch. Entrants shall bowl with the same hand used to establish the entering average they are using for the tournament.
8. It shall be each bowler's responsibility to verify the accuracy of their average. Failure to use the proper average or make corrections prior to completion of the first game of a series shall disqualify the bowler's score, if the submitted average is lower than the actual average. If the submitted average is higher, prize winnings will be based on the submitted average. See USBC Rule 319a.
9. Any bowler whose average has been rerated must use their rerated average in the tournament and report information per USBC Rule 319c. The average of any entrant in this tournament is subject to rerating if either of the following has happened during the 12 months immediately preceding the tournament.
 - A. If the bowler has qualified for a prize of \$300.00 or more in any event of a tournament, the bowler must report all such prizes plus actual scores and positions standing, in accordance with USBC sanctioned tournament rule, see USBC Rule 319d for details.
 - B. If the bowler's average in tournaments has exceeded the bowler's league average by the amount set forth in the USBC Rule 319e, the bowler must submit to the tournament director for the adjustments in accordance with the rerating formula in 319e, see USBC Rulebook for details. Failure to comply may result in disqualification and possible suspension from membership in the USBC.
10. The tournament director reserves the right to rerate any entrant prior to bowling for any reason other than those set forth above. If the entrant refuses to be rerated, the entrant's entry fee will be refunded. Entrants have the right to appeal any rerate to USBC within 15 days of the date of bowling or prior to payment of prizes, whichever comes first.
11. No entrants will be able to practice on scheduled tournament lanes prior to bowling the tournament for any such reason.
12. Bowlers must report to the tournament office at least 30 minutes prior to bowling and must show the bowler's USBC card. The entrant's signature on the front of this application binds them to the rules and regulations of the Ada County USBC tournament.
13. **Dress Code:** It will be each bowler's responsibility to follow the dress code as prescribed by Ada County USBC. The code is as follows: **Shirts with collars**, long pants, slacks, dress shorts will be permitted provided they are not tattered or ragged, T-shirts with the sponsor's name/logo, and any PBA/Ball Manufacturer mock bowling shirt will be accepted. No tank tops, short shorts or ragged attire. Failure to comply with this rule could result in disqualification.
