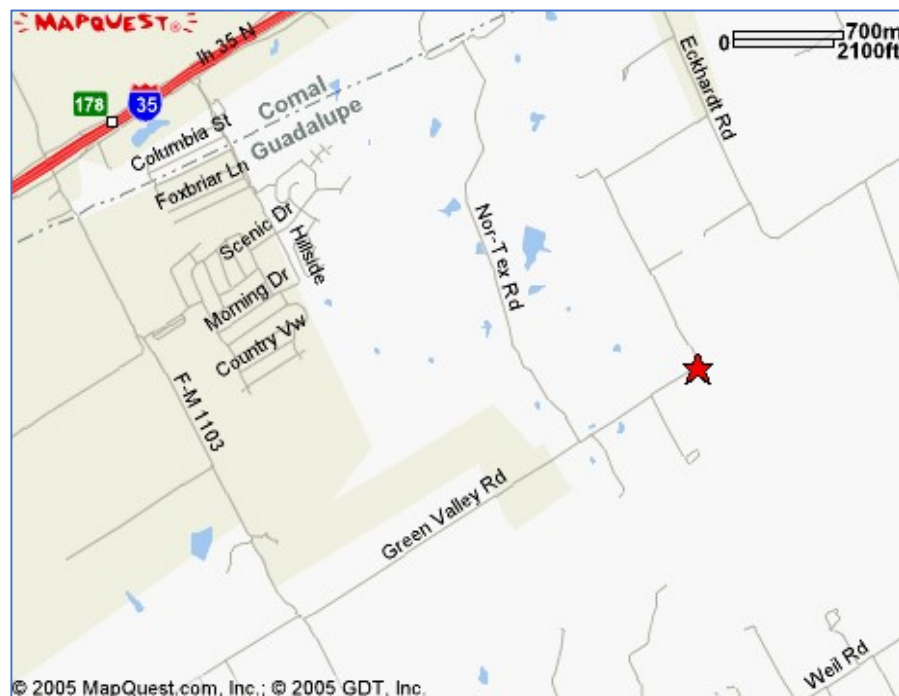
Standard rosettes to be awarded for qualifying scores.
