I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this field trial, however such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

ENTRY FORMS AND ENTRY ELIGIBILITY REQUIREMENTS

It has become increasingly apparent in respect to Pointing Breed trials that the number of ineligible and incomplete entry forms being accepted by Field Trial secretaries has grown considerably. This has resulted in cancellations of rewards, much more often, in the reduction in the number of starters in competition. The following guidelines and interpretations of AKC Rules, Regulations and Policies should be helpful.

Chapter 9, Section 5 of the Field Trial Rules state, in part three "Each form must be completed in full and the information given on the form must be that which applies, to the entered dog." Thus no dog is considered to be entered in a Licensed or Member Club trial unless the entry form is fully completed and signed.

While Field Trial secretaries are not responsible for the correctness of any information appearing on an entry form, the AKC has always held that the Field Trial Secretary and the Club are responsible for the "face value" of the information appearing on the entry form. That is, each entry form for a trial must be completed in full, and a dog's date of birth on the entry form must qualify it for the stake being entered.
