DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative

Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the *Rules Applying to Registration and Discipline* for the listing of registerable breeds that may participate. Puppies under six months of age are strictly prohibited from the trial grounds.

MEASURING and HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the checkin process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the Judge of Record PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a Volunteer Measuring Official (VMO) or an Agility Field Rep is present; ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

ENTRY REQUIREMENTS FOR INTERNATIONAL SWEEPSTAKES CLASSES (ISC)

The international sweepstakes class (ISC) is a non-regular class providing the dog and handler an opportunity to demonstrate their advanced training and handling skills on various international style Standard and Jumpers With Weaves courses. The rules for This class are generally based on international rules. The variety in international agility Course designs is very diverse, so handlers should be prepared to meet the "Challenge Of The Day" when competing in the ISC class. The total challenge level may be easier, more difficult, or simply different from what is currently allowed in excellent/master Class. Complete rules for ISC are

available from AKC's website (http://www.akc.org).

Eligibility: This class is open to dogs that are eligible to compete in AKC agility trials. Jump heights: Dogs may be entered in their regular jump heights, however, only those dogs running in the 12" & 16" class that meet the FCI/ISC measuring cutoff (different than regular AKC Cutoffs) or any dog entering the 24" jump height will be eligible for the direct invitation to World Team Tryouts. The FCI/ISC cutoffs for those heights are as follows: • 12" - Small team – shoulder height = 13 3/4" or less (35 cm is the FCI cutoff) • 16" - Medium team – shoulder height = 16 7/8" or less (43 cm is the FCI cutoff) • 20" - Intermediate team – shoulder height = 18 7/8" or less (48 cm is the FCI cutoff) 24" - Large team – shoulder height = greater than 18 7/8" (greater than 48 cm)

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors on artificial turf.

Ring size will be Ring size is 120 x140. We will be using 24" weave poles, rubberized contact equipment, and breakaway tire.

RIBBONS, AWARDS, AND PRIZES

Rosettes or ribbons will be awarded to first through fourth place in each jump height division. Only qualifying scores are eligible for ribbons.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Yorkshire Terrier Club of the Carolinas and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

Yorkshire Terrier Club of the Carolinas reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Yorkshire Terrier Club of the Carolinas or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

Exhibitors are responsible for cleaning up after their dogs. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

This club agrees to arbitrate claims as set forth on the Official AKC Entry Form for this event.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.

Bitches in season are not permitted to compete in Agility Trials. As such, the club will refund the entry fee paid, less a \$4.00 per run processing fee, for bitches unable to compete for this reason upon presentation of a signed veterinarian certificate. This certificate must be presented to the Trial Secretary no later than 30 minutes prior to the start of judging on March 22, 2025.

Injury/Illness. AKC does not require clubs to offer any refund for dogs that are pulled after closing due to injury/illness. However, as a courtesy to our exhibitors, YTCC offers a partial refund if a request for refund, with required documentation, is presented to trial secretary as defined here: Dogs that cannot compete due to an injury/illness will receive a refund of the entry fee paid minus a \$8.00 per run processing fee. A signed veterinarian letter (on office letterhead) must be presented to the Trial Secretary no later than 30 minutes before the start time on March 22, 2025. Refunds will not be issued after the start of the trial. Letters from chiropractors and massage therapists are not valid. Injuries/illness to handlers are excluded from this policy.

RINGSIDE

Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The owner/handler of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required

Entering For Exhibition Only (FEO)

- For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is allowed in all classes. Participation in FEO is non-qualifying.
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.

- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level (Novice, Open, Excellent, Master) in FAST, JWW, Standard or Premier classes. If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge. Course time for FEO in Time 2 Beat, JWW, Standard, Premier and ISC will be 45 seconds. FAST course times for each class/height are as noted in the Regulations.
- Toys are allowed in the ring. Toys must be non-audible and may not leave the handlers' hand. Toys that roll freely may not be used.
- Food/treats are not allowed in the ring.
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and/or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time.

Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed.

Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1st run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
