MOVE-UPS

Provide dog's call name, owner's name, original class entered and new class requested. Move-ups for Saturday and Sunday must include the above information **and the dog's AKC number** and must be delivered to the Trial Secretary at the trial site no later than 15 minutes after the final dog has run, though earlier is better! A FORM WILL BE AVAILABLE at the Secretary's table. Dogs moved up will generally be placed at the end of the running order.

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct classes, levels and height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

NEW 24" CHOICE JUMP-HEIGHT

Effective January 2, 2018 the new 24" Choice" jump height will replace the 26" jump height. This new 24 Inch Choice jump height is for dogs entered in the Regular division that measure 22 inches and under ONLY, whose handlers choose to enter 24

Inches. Dogs that measure 22 Inches and over that are required to jump 24 inches will stay in the current 24 Inch height. Course times for the 24 Inch Choice will be the same as the 20 Inch height in all classes.

CLASS CHANGES EFFECTIVE JANUARY 1, 2022

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2022, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A SEPARATE ENTRY FORM MUST BE SUBMITTED WHEN THE SAME DOG IS BEING ENTERED IN A MIXTURE OF REGULAR AND PREFERRED AND/OR DIFFERENT JUMP HEIGHTS WITHIN THE SAME TRIAL WEEKEND THEREBY CLEARLY INDICATING WHICH CLASS(ES) AND/OR JUMP HEIGHTS BELONG TOGETHER FOR EACH TRIAL DAY OF THE WEEKEND.

Entering For Exhibition Only (FEO) – WILL BE OFFERED AT THIS TRIAL

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only offered in the Time 2 Beat and FAST classes. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.

- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring. Toys must be non-audible and may not leave the handler's hand. Toys that roll freely may not be used.
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time.

Fix and Go On

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

MEASURING AND HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

RIBBONS, AWARDS, AND PRIZES

Rosettes will be awarded in each jump height division in each class as follows:

A MACH, AGCH or PACH rosette and decorated MACH, AGCH or PACH bar will be awarded to all dog and handler teams that attain their MACH, AGCH or PACH at this trial. COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors, in climate-controlled building on artificial turf surface. Ring size will be 100' x 85'

SITE INFORMATION

- The Bon-Clyde Learning Center is a climate-controlled indoor facility with an 85 x 100 foot area with a recently installed artificial turf surface. The facility has been thoroughly cleaned including the artificial turf.
- Due to limited space, No x-pens (including cloth) or large reclining chairs will be allowed in crating areas.

- All dogs must be on leash at all times except when in the ring or the designated warm-up area.
- American Hairless Terrier Club of America and Bon-Clyde Learning Center will not be responsible for any lost or damaged items left at the show site.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The **safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. **American Hairless Terrier Club of America** and its agents, employees, etc., will

assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. **American Hairless Terrier Club of America** reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the **American Hairless Terrier Club of America** or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Entry fees for ill or injured dogs or bitches that come into season after the closing date will be refunded (minus administrative fee per run of \$5 for BIS, \$10 per run all others) if a veterinarian's certificate is presented to the Trial Secretary prior to the start of judging on the first day of the set of trials. The unexpected death of a dog will be treated in the same manner.

Up to 25 exhibitor entries may be wait-listed following the closing date. Full refunds will be made to exhibitors whose entries are replaced by wait-listed entries prior to July 16, 2022 at 6:00 pm.

RINGSIDE

Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class by the judge of record, unless a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine PartnersSM** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
