VENDOR AGREEMENT

ARTICLE I: VENDOR RULES AND GUIDELINES

- Section 1 All spaces are assigned by The Graham Companies and Miami Lakes Cars for a Cure Inc. and are subject to change up to 10:00 am the day of the event. Special consideration will be considered for items sold, location of Main Street Merchants and other vendors.
- Section 2 All set-up is to be completed by 8:00AM on the day of the Festival. Vehicles are not permitted on Main Street and/or Festival grounds during the event. Set-up may begin 7:30 AM on April 7, 2019. **All vendors are required to remain in their assigned area during the hours of the event**, and shall not breakdown prior to 5:30PM.
- Section 3 **The Graham Companies and Miami Lakes Cars for a Cure reserves the right to limit the number/type of vendors in addition to the right to reject any vendor or ask the vendor to leave the event without refund if the display is deemed inappropriate for the event.**
- Section 4 Vendors are responsible to set-up their own display, clean up their area, and is required to have a minimum of one (1) garbage can with lining. Vendor shall return the assigned space to its original condition. Full length table coverings are mandatory for all tables. Pre-approved colors are black and white. Additional colors must be pre-approved by the Festival Committee. **Food vendors are responsible for adherence to all state and local health laws and necessary certification to serve food items.**
- Section 5 The Festival is an outdoor event that may have inclement weather conditions. The Graham Companies and Miami Lakes Cars for a Cure are not responsible for any damage or theft of any goods, items or vendor displays.
- Section 6 Vendor agrees to provide all service equipment, supplies (tables; chairs; lighting; extension cords may be 12 gauge or larger, 3 wire; hanging material for banners; tape; staples; etc.), personnel, and to assume complete responsibility for the staffing and operation of display. One electrical outlet will be provided per 10'x10' space. **Food Vendors will be allowed a maximum of two (2) small propane tanks for cooking purposes.** All equipment is subject to inspection by The Graham Companies and Miami Lakes Cars for a Cure electrical inspector and must be pre-approved prior to start of event. Please note, electricity is limited.
- Section 7 First time vendors are responsible for attending a **mandatory** orientation held 10 days prior to festival event date.
- Section 8 Applications for candidates for public office or organizations promotional political causes are prohibited and will not be accepted for the Festival.
- Section 9 **FOOD VENDORS ONLY: Food and cooking vendors must maintain a clean and safe work area and are required to have a minimum of one (1) fire extinguisher within immediate reach of cooking area. Oil spills must be cleaned up by vendor.**

ARTICLE 2: PAYMENT, CONFIRMATION, AND TERMINATION OF AGREEMENT

- Section 1 The event is an outdoor event and will be conducted rain or shine. A \$50.00 cancellation fee will be assessed on cancellations on or before March 18, 2019. No refunds will be allowed for cancellations.
- Section 2 The undersigned agrees to the rules and regulations of the Miami Lakes Cars for a Cure and understands that any activity deemed inappropriate by The Graham Companies' authorized personnel, including a violation of the rules of conduct of Main Street will result in immediate dismissal from the event with no refund and a denial of participation in future events not limited to the Miami Lakes Cars for a Cure.
- Section 3 The approval and validation of this document is contingent upon Miami Lakes Cars for a Cure Inc. receiving the full amount due for participation in the total sum of \$_____ Cash (a receipt will be provided) or check payable to ML Cars for a Cure Inc.

ARTICLE 3: RELEASE, WAIVER, AND ASSUMPTION OF RISK

- Section 1 The undersigned (exhibitor), indemnifies and agrees to hold The Graham Companies (Owner) and Miami Lakes Cars for a Cure (coordinator) harmless from any suits, attorney's fees, judgments, loss, claim, liability, damage, cost or expense demand whatsoever in law of equity (including those arising out of any appeals) which may be brought against said Owner now or in the future by an individual, corporation or partnership, governmental agency or other entity which is caused by or arises out of the use of the demised Premises (Main Street Phase I & II North and South and New Barn Road to participate in the Miami Lakes Cars for a Cure) by User.
- Section 2 User assumes full responsibility for all damage, destruction and loss to User's personal property, even in the event this should be caused by an intruding third party, without regard to whether use or any party authorized by the users are present for the above purpose or any other purpose at the time of the intrusion.
- Section 3 This consent is granted by Owner, which is Owner's sole judgment, agrees that the activities are acceptable and should Owner, for any reason, decide that the activities are not acceptable, User agrees to immediately cease and return premises to its original condition at User's expense.
