Treasurer's Report was read and approved by motion of Councilman Lehman, seconded by Councilman Walters. Unanimous roll call vote.

Other Financial reports were approved by motion of Councilwoman Valianti, seconded by Councilman Walters. Unanimous roll call vote.

Rich DiPetro- 208 White Horse Pike-Disappointed that the Borough did not agree to reconsider their discission to transfer the Pilot Agreement. He also claimed that his property manager was treated rudely when he came to the Borough Hall in January to inquire about meeting dates.

Matt-Home Brew Club-Asked if it was possible to reschedule the Home Brew Day since it was cancelled due to rain last weekend. Council agreed that it can be held on May 21st with a rain date of June 18th. It will be held in the Memorial Park Parking lot, not in the street.
