## CAUCUS MEETING MINUTES May 6, 2024

The Meeting was called to order by Mayor Brandley.

The flag salute was led by Mayor Brandley.

Mayor Brandley announced that the meeting was in compliance with the Sunshine Law.

Council Persons présent: Joran, Angelucci and Walters. Council President MacGregor, Councilwoman Valianti and Councilman Lehman were not present.

Council went over the Engineer's report with Shawn Seroka from Key Engineers.

Council went over the tentative agenda for the Council Meeting.

#### Discussion Items:

Request for Event on Borough Property- The Borough received a request from the PTA to use the Memorial Park Parking lot on June 8<sup>th</sup> from 12 pm to 5 pm for their Spring Fling. Also received was a request from the Greater Philadelphia Bike Group to use the parking lot on Jun 8<sup>th</sup> from 4:30 am to 12 pm and Tonewood Brewing from 12 pm to 9:30 pm. Council discussed all of the events requested. It was decided that the Mayor would reach out to all organizations involved and see if a solution could be reached.

Repainting Tennis Courts-Superintendent of Public Works, Rick Hawco, provided an estimate to paint pickle ball lines on the tennis courts. Council request that he move forward with the project.

Zoning Application, 215 W. Clinton Ave.-A previous received zoning application was rediscussed. The application was for a sign that council suggested revisions to. The sign was revised and will be placed on the council meeting agenda to be approved.

Revoking Mercantile License-There was an issue with the mercantile license for 916 White Horse Pike. It has come to the attention of the Borough that the license was not being used as intended. After a brief discussion with the business owner it was decided that the business will be on probation for 90 days.

Dog Park-The Borough's Dog Park is ready to open. It was decided that their will be a ribbon cutting on May 14th at 6 pm.

Clothing Bin Permit Application-An application was received for two clothing bins in the parking lot of 338 White Horse Pike. Council approved the application.
