The Meeting was called to order by Mayor Brandley.

The flag salute was led by Mayor Brandley.

Mayor Brandley announced that the meeting was in compliance with the Sunshine Law.

Council Persons present: Walters, Cairns, MacGregor, Angelucci, Lehman and Valianti

The minutes of the June 9, 2020 Council Meeting and the July 6, 2020 Caucus Meeting were approved by motion of Councilman Angelucci, seconded by Council President Cairns. All in favor-motion carried.

Treasurer's Report was read and approved by motion of Councilman Walters, seconded by Councilwoman Valianti. Unanimous roll call vote.

Other Financial reports were approved by motion of Council President Cairns, seconded by Councilman Angelucci. Unanimous roll call vote.

### **Committee Reports**

**PUBLIC SAFETY**- Saddened to report the passing of former Police Chief John Laggy. Police calls have increased from last year. Reminder to call the Police if there is an issue. Please to not post on social media. Fire Department is happy to report that they had no calls last month.

**PUBLIC WORKS**-Public Works has power washed the monuments. Making repairs to on of our dump trucks. Clean up is complete of the tree down on E. Haddon Ave. The Tree Advisory Board has had a couple meetings. Hoping to make a recommendation to Council in the next month or two.

**BUILDINGS AND GROUNDS**-The windows have been replaced in the tax office. Parking lot at the Borough Hall has been repaved.

**RECREATION AND SENIOR AFFAIRS**-The County should be opening the bids for the Newton Lake Dredging project today. The school is working on their reopening plan. Graduation for Collingswood High School is July 20<sup>th</sup>.

**FINANCE**- Borough Hall is open regular business hours. Public is just not permitted in the building. Drop boxes are located at both doors.

**MAYOR**- A revised construction schedule for the sewer project will be posted on the website.

Lou Monoyious-103 Johnson Ave-Asked Councilman Lehman for an update on the Newton Lake Dredging. Questioned if they were going to dredge all the areas bank to bank. There is still some questions regarding the dredging area.

Rick Santos-52 E. Bettewood Ave.-Inquired about on-street parking overnight. Seems to be a lot more vehicles parking on the street overnight. It was explained to Mr. Santos that due to the Sewer construction project there have been more cars being permitted to park on the street overnight.

Marcie Aron-405 Oaklawn Ave.-Asked when the basketball courts would be reopened. Mayor Bradley explained that the Borough is still assessing the reopening of the basketball courts and is keeping in line with other towns in the county when deciding what to reopen at different times.

Being there was no further discussion, the meeting was closed to the public by motion of Councilman Angelucci, seconded by Council President Cairns. All in favor-motion carried.
