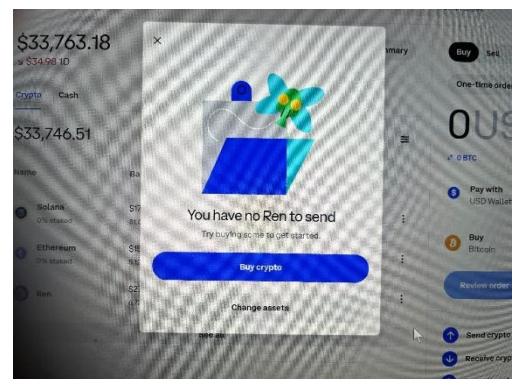
Why did this happen?

While we can't always tell exactly where an attacker may have gotten your password, it's typically due to one of the following reasons:

- Reusing the same password across multiple websites.
- Entering your credentials into a phishing website.
- Inadvertently installing keystroke-logging malware on your computer.

How else can I protect myself?

- Run a malware scan on your computer. Malwarebytes (<https://www.malwarebytes.com>) is a reputable vendor which provides a free tool for this purpose.
- If you reuse your passwords across multiple websites, we recommend changing those too. To make this easier, use a trusted password manager like 1Password or Dashlane, which auto-generates and auto-fills these passwords for you.
- Enable two-step authentication by using a either hardware security key or an app-based authenticator like Google Authenticator to help ensure the safety of your online accounts.
