To Whom It May Concern at the IRS,

I am writing this letter to request a waiver of any penalties I may be subjected to, due to unpaid taxes from 2022 – current. I am not able to calculate my taxes, because of ongoing and relentless cyberattacks, that started around Dec 2022 amidst preparing a whistleblowing report against Teladoc Inc. In addition, there are several issues with my crypto accounts, that I suspect were also hacked. There may also be issues with my previous tax accountants, and I have requested the IRS to remove them from my accounts.

I am trying to resolve these issues and gain access to my crypto accounts. Without access to these accounts, I do not see how it is possible to calculate my taxes correctly. I am also in the process of securing a tax lawyer, as I was strongly recommended to do so on 09/11/24 by the Palm Beach Accounting & Financial Services, LLC/. They refused to accept me as a client, which is understandable after seeing the magnitude of cybercrimes/attacks I am a victim of, and felt it is not appropriate for me to only use a tax accountant and/or financial services. I have reported these cyberattacks to law enforcement and government agencies. I have not received any meaningful guidance regarding these matters, and instead I have been severely reprimanded. Because of the ongoing and relentless cyberattacks, sabotage, and interceptions I have been and currently am unable to work. My health insurance was recently discontinued by someone, and my attempts to get a breast biopsy, to rule out cancer, intercepted. In a nutshell, every facet of my life has been completely destroyed by these cyber gangsters, and I am not allowed any meaningful help by any government agency. Attempts to get assistance from private cybersecurity firms are unfruitful, as emails and/or phone calls do not do through, or they find the hacking "way too advanced" for them to deal with.
