Dear Allis,

In an attempt not to waste even more precious time on everyone's part, and to avoid adding to my anguish in an already very high stakes situation, I would appreciate it if the Florida DOH would answer questions 1- 3 as soon as possible. Mr. [John Terrell](#) informed me yesterday that he is unable to accept my case, so I am formulating my own response as I am doubtful I can obtain a lawyer to represent me.

Additionally, I would like to point out that per your website (link attached) "No person shall be retaliated against, harassed, intimidated, threatened, coerced or discriminated against for making a charge, testifying, assisting or participating in any manner in an investigation, proceeding or hearing, or for opposing alleged unlawful discriminatory practices prohibited by this policy or related to state and federal laws, rules and regulations." While this may, or may not, apply to my situation under EEO, I am confident it does apply under one or more of the "dozens of laws at the federal, state, and local levels designed to encourage whistleblowers to come forward" (link attached).

Despite this, the Florida DOH is in the process of investigating to remove my medical license based on the false allegations, made hastily by Dr. Dahlin who failed to believe that I was hacked and amidst an active investigation, when he visited briefly on 11/17/23 and on 11/18/23. Per documents by the Professionals Resource Network (PRN), I had "exhibited behavior he felt was consistent with delusions and paranoia" and I was also determined to be "noncompliant". I was never evaluated or contacted by anyone from the PRN, nor have I received any notifications from them to date. The documents from the Florida DOH state the same. I was out of the country between 11/23/23 – 01/23/24 visiting Finland, and my mail from this time period was returned to sender. The notification by the FL DOH with tracking number 70190140000058587250 was returned to sender as well, per USPS. How can I then be deemed "noncompliant" by the PRN? Additionally, I find that the "case summary" by PRN has characteristics of gross negligence. On 12/08/23 Dr. Dahlin gave me "one last opportunity" to call PRN, or he would make the report. I disagreed as doing so was completely unwarranted, ignorant, foolish and came with a very high potential for a disastrous and perhaps even dangerous outcome during an active hacking situation, and based on additional information available to me, and not Dr. Dahlin. He was too ignorant to be receptive to any of this. Per documents from the Florida DOH, "a certified letter warning of file closure and DOH referral was sent to Dr. Lahteenmaa on December 4, 2023" by PRN, 4 days prior to my conversation with Dr. Dahlin. Lastly, the information I have provided regarding the whistleblower case against Teladoc Inc., and ongoing and relentless hacking, can be easily and swiftly verified by a quick phone call to the FBI, instead of continuing to greatly intensify my agony needlessly by persecuting and tormenting me with false accusations for up to 45 days, and possibly beyond based on the results.

I want to communicate in no uncertain manner that I do not find this investigation to be ethical, humane or perhaps even legal, as it seems to conflict with numerous whistleblower laws, is unnecessary prolonged in a very difficult high stress/risk situation, and because it lacks any evaluations or contact by the PRN and their timelines are questionable. I find this investigation to be retaliatory in nature. Please kindly answer the following so hopefully the investigation can be concluded, and I can be cleared of these baseless accusations.

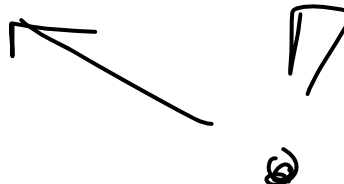

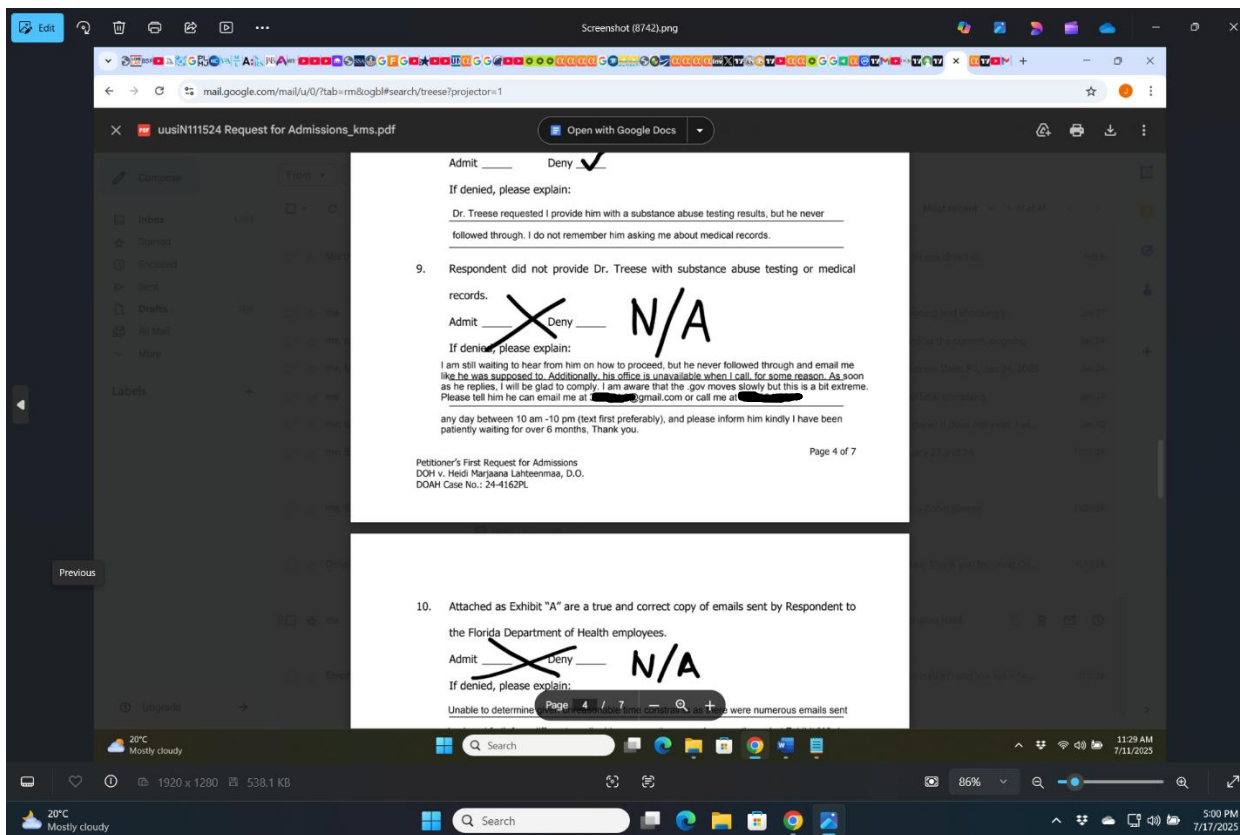
