- 1. Petitioner is the state agency charged with regulating the practice of osteopathic medicine pursuant to chapters 456 and 459, Florida Statutes (2025).
- On August 26, 2024, Petitioner filed an Administrative Complaint against Respondent alleging Respondent violated section 459.015(1)(w), Florida Statutes (2024).

Respondent timely disputed the allegations and requested for the

case to be heard by an Administrative Law Judge, pursuant to section

120.57(1), Florida Statutes.

4. On November 7, 2024, the case was filed with the Division of

Administrative Hearings (DOAH) and assigned Case Number 24-4162PL.

5. The final hearing was held on August 5, 2025, via Zoom Video

Conference.

6. On October 14, 2025, the Administrative Law Judge issued a

Recommended Order that the Board of Osteopathic Medicine enter a Final

Order finding Respondent violated section 459.015(1)(w), Florida Statutes;

suspending her license until she is able to practice with reasonable skill and

safety, with such demonstration of skill and safety including an evaluation by

PRN; and imposing the costs of the investigation and prosecution of this

matter.

7. Respondent has been advised by a copy of this motion that the

Board will consider the record as defined by section 120.57(1)(f), Florida

Statutes.

WHEREFORE, Petitioner requests that this Honorable Board enter a Final

Order in this case.

# MOTION TO ASSESS COSTS IN ACCORDANCE WITH SECTION 456.072(4)

The Department of Health, by and through counsel, and moves the Board of Osteopathic Medicine ("Board") for entry of a Final Order assessing costs against Respondent for the investigation and prosecution of this case in accordance with section 456.072(4), Florida Statutes. As grounds therefore, the Petitioner states the following:

- At its next regularly scheduled meeting, the Board will take up for consideration the above-styled disciplinary action and will enter a Final Order therein.
  - 2. Section 456.072(4), states, in pertinent part, that:

In addition to any other discipline imposed through final order, or citation, entered on or after July 1, 2001, under this section or discipline imposed through final order, or

citation, entered on or after July 1, 2001, for a violation of any practice act, the board, or the department when there is no board, shall assess costs related to the investigation and prosecution of the case. The costs related to the investigation and prosecution include, but are not limited to, salaries and benefits of personnel, costs related to the time spent by the attorney and other personnel working on the case, and any other expenses incurred by the department for the case. The board, or the department when there is no board, shall determine the amount of costs to be assessed after its consideration of an affidavit of itemized costs and any written objections thereto....

- 3. As evidenced in the attached affidavit (Exhibit A), the investigation and prosecution of this case has resulted in costs in the total amount of \$42,898.61.
- 4. The Department is requesting attorney time in the amount of \$23,372.08. The attached outside attorney affidavit (Exhibit B) and accompanying prosecuting attorney affidavit(s) (Exhibit C) indicate that the Department's attorney time in this case is reasonable and justifiable.
- 5. Should Respondent file written objections to the assessment of costs, within ten (10) days of the date of this motion, specifying the grounds for the objections and the specific elements of the costs to which objections are made, Petitioner requests that the Board determine the

amount of costs to be assessed based upon its consideration of the affidavit attached as Exhibit A and any timely-filed written objections.

6. Petitioner requests that the Board grant this motion and assess costs in the amount of \$42,898.61 as supported by competent, substantial evidence. This assessment of costs is in addition to any other discipline imposed by the Board and is in accordance with section 456.072(4).

WHEREFORE, the Department of Health requests that the Board enter a Final Order assessing costs against Respondent.

### AFFIDAVIT OF FEES AND COSTS EXPENDED

BEFORE ME, the undersigned authority, personally appeared JORDAN WARNER who was sworn and states as follows:

- 1) My name is Jordan Warner.
- 2) I am over the age of 18, competent to testify, and make this affidavit upon my own personal knowledge and after review of the records at the Florida Department of Health (DOH).
- 3) I am the acting Investigation Manager for the Consumer Services and Compliance Management Unit for DOH. The Consumer Services Unit is where all complaints against Florida health care licensees (e.g., medical doctors, dentists, nurses, respiratory therapists) are officially filed. I have been in my current job position for more than one year. My business address is 4052 Bald Cypress Way, Bin C-75 Tallahassee, Florida 32399-3275.
- 4) As Investigation Manager of the Consumer Services and Compliance Management Unit, my job duties include reviewing data in the Time Tracking System and verifying that the amounts correspond. The Time Tracking System is a computer program which records and tracks DOH's costs regarding the investigation and prosecution of cases against Florida health care licensees.
- 5) As of today, DOH's total costs for investigating and prosecuting DOH case number(s) 2023-54547 (Department of Health v Heidi Marjanna Lahteenmaa, D.O.) are FOURTY TWO THOUSAND EIGHT HUNDRED NINETY-EIGHT DOLLARS AND SIXTY-ONE CENTS(\$42,898.61).
- 6) The costs for DOH case numbers **2023-54547** (Department of Health v **Heidi Marjanna Lahteenmaa, D.O.**) are summarized in Exhibit 1 (Cost Summary Report), which is attached to this document.
- 7) The itemized costs and expenses for DOH case numbers 2023-54547 (Department of Health v Heidi Marjanna Lahteenmaa, D.O.) are detailed in Exhibit 2 (Itemized Cost Report and Itemized Expense Report and receipts), which is attached to this document.
- 8) The itemized costs as reflected in Exhibit 2 are determined by the following method: DOH employees who work on cases daily are to keep track of their time in six-minute increments (e.g., investigators

and lawyers). A designated DOH employee in the Consumer Services Unit, Legal Department, and in each area office, inputs the time worked and expenses spent into the Time Tracking System. Time and expenses are charged against a state health care Board (e.g., Florida Board of Medicine, Florida Board of Dentistry, Florida Board of Osteopathic Medicine), and/or a case. If no Board or case can be charged, then the time and expenses are charged as administrative time. The hourly rate of each employee is calculated by formulas established by the Department. (See the Itemized Cost Report)


