Dear Mr. Morris,

I demand the true initial complaint filed against me by Dr. Robert Dahlin, associated with DOH Complaint #54547 or #2023-56447, under Florida Statutes Section 456.073(10). I have endured this ordeal for over two years, and it looks like the Florida DOH has opened a court case against me without there even being a complaint, which is unacceptable.

On December 10, 2024, you claimed no complaint existed, yet today on May 19, 2025, you provided a PRN/DOH Investigator Communication Form (dated January 4, 2024, Exhibit #4) labeled as the "initial complaint" for Case No. 24-004162PL. This is a secondary referral, not Dr. Dahlin's original written, signed complaint, which I am entitled to see. Your email today, citing a 30-day response period and alleging delivery to my attorney on November 22, 2024, does not excuse this delay or satisfy my legal right to the document.

Provide Dr. Dahlin's original written, signed complaint immediately. Your inconsistent statements and prolonged denial—despite my suffering—point to egregious procedural misconduct. If you fail to comply by May 21, 2025, I will escalate this to the Florida Attorney General's Office as a blatant violation of my due process rights, exposing the DOH's actions in this unjust ordeal.
