## **Digital Millennium Copyright Act (DMCA) Notice**

6. Your electronic or physical signature.

In the event LandShapes Construction, LLC removes the allegedly infringing materials, LandShapes Construction, LLC will immediately notify the person responsible for posting such materials that LandShapes Construction, LLC removed or disabled access to the materials. alleged infringing party with your email address so that that person can respond to your allegations.
