Please read your contract, fill out, sign and return with the amount due. Contract will not be accepted until the required 50% deposit it received.

A service charge of 1.5 % per month (18% per year) will be assessed on balances due. In the event legal action is necessary, the "Captain" agrees to pay all collection costs and/or attorney's fees.

RULES AND REGULATIONS

- Dockage charges are based on length plus extensions, such as bowsprits, swim platforms, davits, etc. and are subject to verfication by measurement.
- 2. Dockage shall be paid in advance to cover the full season. Half payment is due with contract. Full payment is due on or before rental period. If vessel is docked prior to rental period, then the balance is due in full at that time. Contract will terminate upon change of ownership of vessel and the new owner must re-apply as a new customer. DEPOSITS ARE NON-REFUNDABLE.
- 3. The Captain agrees that a vessel berthed at the Blue Marlin Docks beyond the date agreed upon on this contract without the expressed written permission of Blue Marlin, or without a new dock rental contract or transient contract shall be considered an abandoned vessel.
- 4. Any boat signed for dockage at Blue Marlin must be in safe and seaworthy condition. It must be registered, identified, marked, maintained, and equipped by law and safe practice
- 5. The Captain agrees to have his or her boat insured with complete marine coverage including liability and will provide Blue Marlin with evidence of such coverage upon demand. Each Captain will be held responsible for damage that he or she may cause to other boats in the marina or to the structures or facilities thereof. All personal property including but not limited to automobiles, trailers, electronics, fishing gear, rafts, tools, and minor equipment stored at Blue Marlin on any vessels at anytime are at sole risk and responsibility of the Captain.
- 6. There will be no filling of fuel tanks from vehicles or containers brought to Blue Marlin. Barbeque grills cannot be used at Blue Marlin. Air conditioners must not be left on unless the Captain is present. All garbage and other refuse must be placed in proper receptacles provided by Blue Marlin.
- 7. Boat owners are allowed to work on their own boats. No outside contractors or service organization will be allowed to work on a Captain's boat unless they have permission from Blue Marlin and furnish proof of adequate liability insurance. Once admitted, the work, conduct and payment of such person and firms are the sole responsibility of the contracting Captain.
- 8. The Captain shall be solely responsible for the safety of his or her vessel. Should Blue Marlin discover that the vessel is in peril, the Captain does hereby authorize Blue Marlin to render assistance to the vessel. If Blue Marlin renders direct assistance to the vessel, Captain agrees to pay Blue Marlin, all charges and expenses of Blue Marlin for labor and materials for the vessel in connection with such peril. The Captain hereby also authorizes Blue Marlin to contract with licensed salvage service or repair contractors if aid or assistance is required at the sole expense of the owner. Captain agrees to settle any charges or expenses incurred directly with said contractors. If the vessel sinks, the Captain shall be responsible for all costs for removal and any necessary clean-up and will conduct such clean-up in accordance with all Bahamian and local rules.
- 9. When a boat enters Blue Marlin Marina, it immediately comes under the jurisdiciton of Blue Marlin and shall be berthed only where ordered. Blue Marlin reserves the right to move the Captain's vessel at its discretion.
- 10. There will be no commercial chartering of any kind, at any time, on any vessel berthed at Blue Marlin unless previous arrangements are made with Blue Marlin office.
- 11. There will be no posting of "For Sale" signs. There will be no attaching of any materials to docks or pilings without authorization from Blue Marlin office. All dock hoses must have trigger nozzles.
- 12. Any infraction of the above rules and regulations and any breach of the provisions of the agreement including failure to pay for work completed shall, at its option enable Blue Marlin to cancel this contract upon 10 days notice, and the Captain shall, upon request, forthwith remove his boat.
- 13. Air conditioners must be turned off when the vessel is unoccupied.
- 14. The Captain releases EJE Enterprise Ltd and its directors, officers, employees and agents from any claims, liabilities, losses, damages, costs or expenses relating to injuries or arising from injuries or incurred by the Captain or the Captain's guests while on the premises of Blue Marlin Marina.
