## Notes:

1. From 6 April 2008 until 5 April 2011, the UK Government will add an extra 3p for every £1 donated under Gift Aid, which means that a charity will receive a total of 28p for every £1 donated.
2. You can cancel this Declaration at any time by notifying **Homes for Wells**
3. If in the future your circumstances change and you no longer pay sufficient tax, you should cancel the declaration by notifying **Homes for Wells**
4. If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
