Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19 & Participation

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. SF Juniors Volleyball Club (SFJRS) has put in place comprehensive plan to reduce the spread of COVID-19; however, SFJRS cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending any SFJRS camp or club events could increase your risk and your child(ren)'s risk of contracting COVID-19. The additional risks of injury involved with athletic activities is significant, including the potential for permanent disability or death.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending SFJRS camps and that such exposure or infection and participation may result in personal injury, illness, permanent disability, or death. I understand that the risk of becoming exposed to or infected by COVID-19 at SFJRS may result from the actions, omissions, or negligence of myself and others, including, but not limited to, SFJRS employees, facility personnel and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at SFJRS or participation in SFJRS programs ("Claims"). On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless SFJRS, St Thomas More School, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I have reviewed and understand the safety plan and camp procedures as written by SFJRS.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of SFJRS, St Thomas More School, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during or after participation in any SF Juniors camp or club program.
