 The bridge repair proposals will be reworked with new vendors following an inability of the earlier-selected vendor to agree to properly repair the bridges.

 The board discussed the legal opinion regarding Quality Landscape. More discussion is required before a vote can take place.

 HiTech Landscaping contractor began serving LOPF HOA on February 1, 2020.

 Deed restriction letters are to be sent for pressure washing homes and removing tree stakes.

The board discussed opening the pool to residents at Pine Forest Green. This
topic was tabled for more discussion and to get a legal opinion for liability.
