All Contractors are urged and expected to inspect the site where work will be performed. Failure to attend site visit may not be used as an excuse for omission or miscalculation in bids.

Fort Sill has implemented an Access Control procedure that requires registration by any visitor to Fort Sill prior to gaining access. #### 4. Basis of Award
