NON-DISCLOSURE AGREEMENT

THIS NON-DISCLOSURE AGREEMENT ("A	Agreement") is made and entered into as of this
30th day of June 2024, by and between SV	D Beaumont, hereinafter referred to as the
"Club," and	, hereinafter referred to as the
"Player."	

- **1. PURPOSE** The purpose of this Agreement is to prevent the unauthorized disclosure of confidential information as defined below. The parties agree to enter into a confidential relationship with respect to the disclosure of certain proprietary and confidential information ("Confidential Information").
- **2. DEFINITION OF CONFIDENTIAL INFORMATION** For purposes of this Agreement, "Confidential Information" includes, but is not limited to:
 - Game day tactics and formations
 - Non-published official team events and documents
 - Any other information that the Club deems confidential or sensitive

3. OBLIGATIONS OF THE PLAYER

- 3.1 The Player agrees not to disclose, discuss, or otherwise make available any Confidential Information to the public, other groups, or parties without the prior written consent of the Club.
- 3.2 The Player shall take all reasonable measures to protect the secrecy of and avoid disclosure and unauthorized use of the Confidential Information.
- 3.3 The Player shall not disclose Confidential Information to any other team, club, organization, media outlet, or third party.
- 3.4 The Player agrees that they will not use the Confidential Information for any purpose other than in connection with their duties as a player for the Club.
- **4. EXCLUSIONS FROM CONFIDENTIAL INFORMATION** The Player's obligations under this Agreement do not extend to information that is:
 - Publicly known at the time of disclosure or becomes publicly known through no fault of the Player
 - Discovered or created by the Player before disclosure by the Club

- Learned by the Player through legitimate means other than from the Club or the Club's representatives
- Disclosed with the prior written approval of the Club
- **5. TERM** This Agreement shall commence on the date first written above and shall continue in full force and effect for as long as the Player is under contract with the Club and for a period of 5 years thereafter.

6. REMEDIES

- 6.1 The Player acknowledges that any violation of this Agreement may cause irreparable harm to the Club, and agrees that the Club shall be entitled to seek injunctive relief in addition to any other remedies available at law or in equity.
- 6.2 In the event of a breach of this Agreement, the Club reserves the right to terminate the Player's contract and pursue any other legal or equitable remedies available.
- **7. GOVERNING LAW** This Agreement shall be governed by and construed in accordance with the laws of Texas, United States.
- **8. ENTIRE AGREEMENT** This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements and understandings, whether written or oral, relating to such subject matter.
- **9. AMENDMENTS AND WAIVERS** Any term of this Agreement may be amended or waived only with the written consent of both parties.
