



## FOOTBALL PLAYER CONTRACT

**THIS AGREEMENT** is made and entered into as of this 30th day of June 2024, by and between SVD Beaumont (SVD BMT), hereinafter referred to as the "Club," and

\_\_\_\_\_, hereinafter referred to as the "Player."

### 1. TERM OF AGREEMENT

1.1 This Agreement shall commence on June 30, 2024, and shall remain in full force and effect until June 29, 2025, unless earlier terminated, extended, or renewed in accordance with the provisions of this Agreement.

1.2 The initial contract length is for one year, with the possibility to renew it for up to 3 additional years. The Club holds the right to renew the contract annually.

### 2. POSITION AND DUTIES

2.1 The Club hereby engages the Player as a semi-professional soccer player to perform such duties as are consistent with this role, including but not limited to training, practicing, and participating in matches and competitions as directed by the Club's management and coaching staff.

2.2 The Player agrees to use their best efforts and abilities to perform their duties for the Club and to comply with all Club rules, regulations, and policies.

### 3. COMPENSATION

3.1 Bonus Compensation: The Player shall be compensated with a bonus at the end of the season if the team wins the league and earns promotion to UPSL Premier Division. The bonus amount shall be specified later.

3.2 No other Salary: The Player acknowledges that they will not receive any other salary or compensation during the term of this Agreement.

3.3 Benefits: The Club shall provide the Player with the following benefits:

- Travel and accommodation for away games; if necessary
- Access to training facilities and equipment

#### **4. PLAYER OBLIGATIONS**

4.1 The Player agrees to maintain a high level of physical fitness and to participate fully in all training sessions, practices, and matches.

4.2 The Player agrees to conduct themselves in a professional manner both on and off the field and to uphold the reputation and image of the Club.

4.3 The Player agrees not to engage in any activities that may impair their ability to perform their duties, including but not limited to engaging in other professional sports or hazardous activities.

#### **5. TERMINATION**

5.1 The Club may terminate this Agreement for cause, including but not limited to:

- Breach of contract by the Player
- Misconduct or behavior detrimental to the Club.

5.2 The Player may terminate this Agreement for cause, including but not limited to:

- Breach of contract by the Club
- Failure to provide agreed-upon compensation or benefits.

5.3 Termination by mutual consent: This Agreement may be terminated at any time by mutual written consent of both parties.

#### **6. EXTENSION AND RENEWAL**

6.1 The Club reserves the right to extend or renew this Agreement under mutually agreed terms.

6.2 If the Club intends to extend or renew the Agreement, it shall notify the player before the expiration of the current term.

#### **7. INJURY AND MEDICAL TREATMENT**

7.1 The Club agrees to provide the Player with medical treatment and care for any injuries sustained while performing duties for the Club.

7.2 In the event of a serious injury that prevents the Player from performing their duties, the Club may place the Player on the injured reserve list.

## **8. IMAGE RIGHTS**

8.1 The Player grants the Club the right to use their name, image, likeness, and biographical details for promotional and commercial purposes related to the Club.

## **9. SOCIAL MEDIA AND PUBLIC POSTINGS**

9.1 The Player agrees to be vigilant with what they post on social media and other public platforms to avoid tarnishing the image of the Club.

9.2 The Player must obtain approval from the Club before posting any material they are unsure about or that could be considered sensitive or controversial.

9.3 The Player understands that failure to comply with these guidelines may result in disciplinary action, up to and including termination of this Agreement.

## **10. BUYOUT CLAUSE**

10.1 The Player agrees that if another club wishes to acquire his services while he is under contract with the Club, the interested club must pay a buyout fee to the Club.

10.2 The Player acknowledges that the buyout fee is non-negotiable and must be paid in full before any transfer negotiations can commence.

10.3 The Player and the interested club must adhere to all applicable transfer regulations and protocols as stipulated by the governing football authorities.

## **11. EXCLUSIVITY**

10.1 The Player agrees not to play for any other team while under contract with the Club. This includes Sunday leagues and any other leagues during the week.

10.2 Special provisions may be given to certain players pending the approval of the Club's board.

## **12. DISPUTE RESOLUTION**

12.1 Any disputes arising under this Agreement shall be resolved through good faith negotiations between the parties.

**13. GOVERNING LAW** This Agreement shall be governed by and construed in accordance with the laws of Texas, USA.
