II.1. System Overview

Vertilinc Live! is an automated control and information management system designed for communities, commercial buildings, condominiums, and residential neighborhoods looking to integrate administration and common services under a unified intelligent platform through a user-friendly, intuitive, graphical interface. Through this platform residents can take advantage of all services offered at their property and managers have 24/7 access to resident's data and management modules.

For residents, Vertilinc Live! is accessed via a web interface or via any mobile device with web surfing capabilities. This allows for residents to access all of the features available in Vertilinc Live! from their home, office or from anywhere in the world. Users can reserve facilities, view account balances, make online payments, view violations and code-compliance issues, order cleaning services or babysitter services, and receive instant property communications, notifications and events in their own personalized information portal.

For property managers, Vertilinc Live! is a full property management system where managers and the board of directors can centrally administer all aspects of the property. Property managers can send and track violations, check in/out keys, manage resident information such as spouse, pets, children, emergency contact information, and warranty information; maintenance personnel can manage inventory, maintenance work orders, and staff; and security staff can manage property incidents, staff and notifications. - Spa Service requests

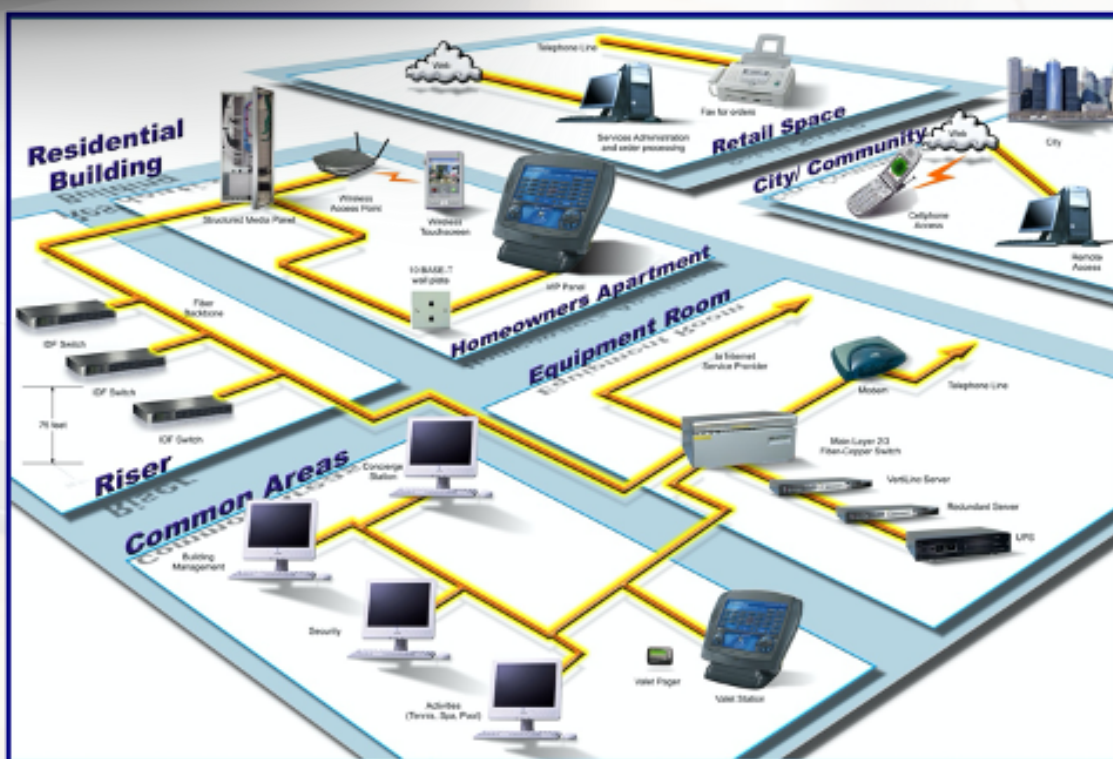

II.3. System Requirements

Vertilinc Live! System can be installed on a shared or dedicated server. This proposal is for installation on an offsite server, co-located at one of our datacenters. The bandwidth requirement from the server is negligible when calculating bandwidth allocation for traffic from the property although speed is important for system responsiveness. We recommend installing Uninterrupted Power Supplies (UPS) at key workstations as the system can operate in offline mode when the power or the Internet connection are interrupted. All workstation hardware will be supplied by client.

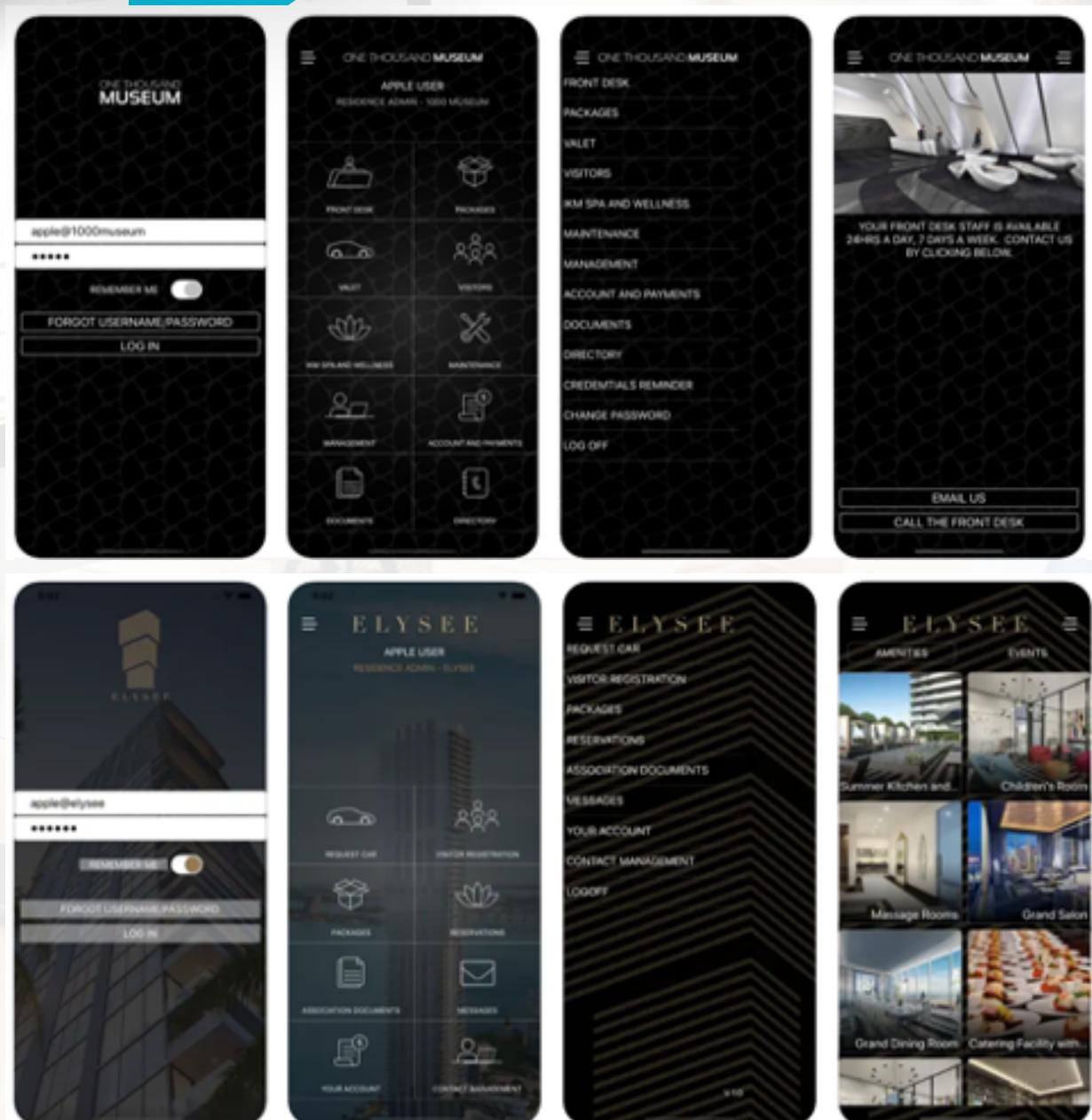

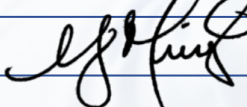
